## US-PH SOCIETY VOWS GREATER COOPERATION IN PH ECONOMY, DEV'T INITIATIVES

AN organization of prominent Filipino and American civic and business leaders on Tuesday, May 2 vowed for greater cooperation and partnership in the development and economy of the Philippines.

The United States-Philippines Society, (USPS) co chaired by US Ambassador John D. Negroponte, made the commitment following the group's meeting with President Ferdinand R. Marcos Jr. in Washington.

Negroponte said the Philippine leader's visit to

Washington last Monday, May 1 laid the framework for the commitment of the group to support Manila.

"(The) President's visit... sets the table for our work, of US-Philippine Society in the months and years ahead, thank you for that," Negroponte told President Marcos.

Also known as The Society, the USPS is a non-profit, bi-national organization of prominent civic and business leaders of the US and the Philippines.

Former ambassador Negroponte co chairs The

Society with prominent Filipino businessman Manuel V. Pangilinan.

The Society was organized in May 2012 is a strong partner of the Philippine Embassy in Washington, D.C. in organizing events that highlight the robust relations between the Philippines and the United States in promoting security, economic, cultural and social interests.

Marcos, for his part, talked about his meeting with US President Joe Biden, particularly on how Manila and Washington

Gamit ang modernong digital technology, inihalimbawa ni Tolentino na sirain ang sistema ng pagbabangko ng Pilipinas.

'Cyberattack' ito na wawasak sa mga ahensiya ng gobyerno tulad ng nangyaring 'data leaks' sa National Bureau of Investigation (NBI), sabi ni Tolentino.

Dahil dito, nais ng senador na amendahan ang Article 5 ng 1951 MDT at magdagdag ng probisyon tungkol sa paano madedepensahan ang bansa laban sa cyberattack.

"If there is a cyber-attack, the banking system will be damaged. So with all critical government infrastructures—brownouts, blackouts nationwide, even telecommunications," sabi ni Tolentino.

MADALAS waterless, pero patuloy ang water rate increase ng dalawang concessionaire ng Waterworks and Sewerage System (MWSS, dating National Water and Sewerage System, Nawasa).

Panay lang paaala na magtipid ang Maynilad at Manila Water sa kanilang customer, pero ano ang ititipid kung walang tubig sa gripo, at kung mayroon man, patak-patak at madalas sa gabi ang daloy ng tubig.

Maraming napupuyat sa pagkainis sa matiyagang pag-iipon ng tubig na ayon sa Article III (National Economy Patrimony) Section 2 ng 1987 Constitution. "mandates that all water resources are owned by the State and shall not be alienated."

Tuwing tag-ulan, maraming namamatay sa pagkalunod sa baha na noong panahon ni dating Presidente Ferdinand Marcos Sr. ay inoobliga ang bawat rehiyon, lalawigan o lokalidad na magtayo ng small water impounding management (SWIM).

Sa SWIM, maglalaan ang lokal na gobyerno ng kayang lawak ng lupa na gagawing water reservoir o munting dam o lawa na doon iipunin ang tubig ulan.

Kahit magiong matindi pa ang El Nino phenomenon, may magagamit na tubig kung kapusin ang supply mula sa mga local water district.

Nasa peligro ang food security program ni Pres. Ferdinand Marcos Jr. dahil kakapusin ang tubig irigasyon at paano palalakihin ang ani sa bukirin, palaisdaan, livestock at iba pa, kung walang tubig.

Sa tindi ng mahigit sa 40 degree heat index sa Metro Manila at sa maraming lalawigan, nakiusap si Jose Dorado Jr. deputy admin ng MWSS sa LGUS na magpasa ng orinansa na pansamantala munang ibawal ang madalas na car wash at pagliligo ng mga bata na gamit ang inflatable swimming pool.

Ang pagbawalan mo, Sir Dorado ay yung may mansion na maya malalaking swimming pool, ang mga golf clubs na malakas gumamit ng tubig.

Mas mabuting pagsabihan ng MWSS ang Manila Water at Maynilad na mula nang gawing concessionaire ay taon-taon nagtataas ng singil sa tubig.

1995 nang ibigay sa Maynilad at Manila Water ang production at distribution ng tubig at sa

loob ng 10 taon, mula Agosto 1997-2007 umabot sa 357.6% itinaas ng singil ng Maynilad at 414% naman sa Manila Water.

Sa kasunduan, pinapayagan ng gobyerno (MWSS) na taon-taon kung kailangan, mag-increase ng singil sa kunsumo ng tubig at

nangyari, bilyon-bilyong piso ang kinita ng Maynilad at Manila Water, na sana, naipasok sa kaban ng pamahalaan.

Nai-privatized ang water service dahil nagkautang ang MWSS ng \$307 million noong 1995, na dito \$204 milyon ang nautang sa World Bank at Asian Development Bank (ADB).

Para raw maisalba ang operasyon ng MWSS, iniutos ni Pres. Fidel Ramos, ayon sa National Water Crisis Act of 1995 nakuha ng Maynilad ang west zone at east zone ng Metro Manila sa Manila Water.

Sa kontrata, aakuin ng Lopez owned Ben Press Holding ang west zone -- na hawak ngayon ni Manny V. Pangilinan-- ang 90% ng utang at 10% naman ng Manila Water ng pamilya Ayala.

Tamang desisyon daw ito, sabi ni Ramos na sigurado sa publiko, mababa ang water rates na hindi nangyari.

Kasi, ang daming nakatagong sistema sa kasunduan na malaya ang dalawang concessionaire na bawiin ang lahat ng gastos sa operasyon, distribusyon sa sistemang Rate Rebasing, at dagdag dito, kapag humina ang piso kontra dolyar, babawiin ang "nalugi" sa palitan sa ginawang oreign currency differential adjustments (FCDA) at accelerated extraordinary price adjustment (AEPA).

At dagdag na perwisyo ang dagdag na P1 per cubic meter para raw sa currency exchange rate adjustment (CERA) m at alam nyo ba, kapag nasira ang tubo ng

tubig na noong pang World War II naikabit ang nasayang na bulwak ng tubig, ang consumer ang nagbabayad.

Kung may mga bahay, kompanya na nagnanakaw ng tubig, sinisingil ito sa publiko sa tinatawag na "non-revenue water."

Nagbabayad pa ang consumer ng sanitation fee at sa sewerage dahil daw sa inaayos ang mga imburnal, nagtayo sila ng water treatment facilities at iba pang makinarya para raw maging potable ang tubig nila.

E hindi naman derestong maiinom ang tubig mula sa gripo ng Maynilad at Manila Water.

Onerous ang kontrata kaya ipinatigil ng MWSS ang otomatikong water rate increase kaya nagdemanda sa arbitration court sa Singapore ang Maynilad at Manila Water -- at natalo ang gobyerno kaya naniningil ang Manila Water ng Php7.4 bilyon at ang Maynilad ng Php3.6 bilyon.

Nag-alburoto si dating Presidente Rodrigo Duterte at binataang kakasuhan ng economic sabotage at babawiin ang concession agreement, kasunod ang umaatikabong put%\$#@! kina MVP at Ayala.

Alam nyo bang gumastos ang MWSS ng \$400,000 noong 1999-2000 at dagdag na P230 milyon sa mga kasong isinampa ng Maynilad at Manila Water sa ating korte at sa arbitration court sa Singapore.

Sa takot sa bantang ipakukulong, tumiklop si MVP at Ayala na hindi na raw maniningil at payag ding baguhin ang concession agreement sa MWSS.

Kung ano ang nangyari sa onerous contract ng MWSS, Maynila at Manila Water, walang balita ngayon ang publiko, samantala, panay ang iyak, hinaggis ng mga consumer: walang tubig!

Sa maraming bayan at siyudad sa Cavite, nakikiiusap ang mga mamamayan sa kanilang mayor at kay Gov. JonVic Remulla na sana gawan ng aksyon ang very poor service ng Maynilad.

**PROVINCIAL ORDINANCE NO. 387-2023**

**AN ORDINANCE DECLARING THE SECOND WEEK OF AUGUST OF EVERY YEAR AS THE ANNUAL OBSERVANCE AND CELEBRATION OF THE LINGGO NG KABATAAN IN THE PROVINCE OF CAVITE PURSUANT TO REPUBLIC ACT NO. 10742 OR “THE SANGGUNIANG KABATAAN REFORM ACT OF 2015”**

**WHEREAS**, Section 13, Article II of the Constitution provides that “The State shall recognize the vital role of the youth in nation-building and shall promote and protect their physical, moral, spiritual, intellectual and social well-being and shall inculcate in the youth patriotism and nationalism, and encourage their involvement in public and civic affairs;

**WHEREAS**, Section 30, Chapter VI of Republic Act No. 10742, otherwise known as the Sangguniang Kabataan Reform Act of 2015, provides that every local government unit shall conduct an annual activity to be known as the “Linggo ng Kabataan” on the week where the 12th of August falls to coincide with the International Youth Day;

**WHEREAS**, the Local Government Unit shall establish adequate, effective and enabling mechanism and supports that will ensure the meaningful participation of the youth in local governance and nation building;

**WHEREAS**, the Executive-Legislative Agenda of the Provincial Government of Cavite for the year 2022 -2025 includes

and prioritizes the development of the youth in terms of the protection of their rights, promotion of their general welfare, as well as development of an active and empowered youth sector;

**WHEREAS**, the celebration for the youth and conducting activities devoted to their total development would help and properly address the role of the youth in society and that would determine investment in their development through livelihood training, sport minding activities and personality development;

**WHEREAS**, there is a need for the Province of Cavite to institutionalize the annual observance and celebration of the Linggo ng Kabataan to recognize the vital role of Caviteño youth in their involvement in community affairs that can enhance their physical and social well-being;

**NOW, THEREFORE**, on motion of Hon. Ardemer, duly seconded by Hon. Bautista and Hon. Sison and unanimously approved by the members present, be it enacted by the SangguniangPanlalawigan of Cavite in a session duly assembled that:

**SECTION 1. SHORT TITLE.** This ordinance shall be known and cited as “The Linggo ng Kabataan Ordinance of the Province of Cavite”.

**SECTION 2. DECLARATION OF POLICY.** The Provincial Government of Cavite has the responsibility to enable the Caviteño Youth fulfill their vital role in nation-building. To this end, it shall create or establish structures, support programs and other activities in the province on a continued sustainable basis that will help them become mature, self-reliant and responsible individuals. In addition, there is a need for the province to celebrate the “Linggo ng Kabataan” to plan out and prepare activities that are focused on the needs and demands of the youth of this province.

**SECTION 3. GENERAL OBJECTIVES.** The Linggo ng Kabataan aims to achieve the following purposes:

1. To inculcate among the youth the love of country, discipline, civic mindedness, unity, courage, respect for the rights of others, sportsmanship and quest for excellence.
2. To promote competition as a tool for brotherhood, cooperation and develop camaraderie among the youth.
3. To serve as the training ground for the implementation of government projects and programs for the youth.

**SECTION 4. PROGRAM OF ACTIVITIES.** The SangguniangKabataan Provincial Federation in cooperation with the Provincial Youth and Sports Development Office (PYSDO), in line with the celebration of the “Linggo ng Kabataan” shall formulate and implement programs and conduct activities that shall provide holistic development and enrichment of the youth in their respective communities .The program of activities may include discussions and/or forums on career paths, sustainable development, environment preservation, gender equality and mental health. They may engage partnership with local and international youth organizations to promote and facilitate related activities in all public or private schools.

**SECTION 5. IMPLEMENTING OFFICE.** The Provincial Youth and Sports Development Office (PYSDO) together with the Provincial Youth Development Council (PYDC) shall formulate plans and activities in line with the celebration of the Linggo ng Kabataan of the Province of Cavite and must be submitted and coordinated to the SangguniangKabataan Provincial Federation Office.

**SECTION 6. FUNDING.** For effective implementation of this ordinance, the Provincial Government shall appropriate necessary funds to defray the expenses of this activity.

**SECTION 7. SEPARABILITY CLAUSE.** In any part or portion of this ordinance is declared unconstitutional, the other remaining part or portion not affected thereby shall remain valid and in effect.

**SECTION 8. REPEALING CLAUSE.** All ordinances contrary to this ordinance are hereby deemed repealed or modified accordingly.

**SECTION 9. EFFECTIVITY CLAUSE.** This ordinance shall take effect after its approval and compliance with posting and publication requirements.



**PROVINCIAL ORDINANCE NO. 388-2023**

**AN ORDINANCE DECLARING 10th DAY OF DECEMBER AS HUMAN RIGHTS DAY AND 4th TO 10th DAYS OF DECEMBER AS HUMAN RIGHTS AWARENESS AND CONSCIOUSNESS WEEK IN THE PROVINCE OF CAVITE, PROVIDING GUIDELINES, APPROPRIATING FUNDS, AND FOR OTHER PURPOSES THEREOF**

**WHEREAS**, the 1987 Philippine Constitution under Article III, Section 1, declares that no person shall be deprived of life, liberty, or property without due process of law, nor shall any person be denied the equal protection of the laws;

**WHEREAS**, the Universal Declaration of Human Rights (UDHR) which has served as the basis of our Constitutional Bill of Rights in almost every country throughout the globe, celebrates every 10th of December of every year as the Human Rights Day and 4th to 10th days of the same month as Human Rights Awareness and Consciousness Week, calls upon all citizens, officials, and all concerned individuals and office to publicize the text as provided in Proclamation No. 225, Series of 1950;

**WHEREAS**, Republic Act No. 9201, also known as National Human Rights Consciousness Week Act of 2002, supports and advocates any particular lifestyle or religious view, that all persons be treated fairly and equally, and guarantees all of fair and equal treatment under the law;

**WHEREFORE**, Section 16 of the Local Government Code of 1991, also known as Republic Act 7160, states that every local government unit shall exercise powers necessary, appropriate, or incidental for the efficient and effective governance, and those in consonance which are essential to the promotion of general welfare and contributes to nation-building;

**NOW, THEREFORE**, on motion of Hon. Bencito, duly seconded by Hon. Belamide, Hon. Enriquez and Hon. Sison and unanimously approved by the members present, be it enacted by the Sangguniang Panlalawigan of Cavite in a session duly assembled that:

**SECTION 1. SHORT TITLE.** This ordinance shall be known and cited as the “CAVITE HUMAN RIGHTS DAY AND AWARENESS AND CONSCIOUSNESS WEEK ORDINANCE”.

**SECTION 2. DECLARATION OF POLICY.** It is hereby declared the policy of the Provincial Government of Cavite to ensure that all persons within its jurisdiction shall have equal access to fair treatment, and shall be protected in the enjoyment of civil rights, strengthen interdependence in all areas of cooperation which will help improve quality of life and empower the community towards mutual peace and prosperity, and to promote mutual understanding and respect among all living and working within the province.

**SECTION 3. GENERAL GUIDELINES.** The Office of the Provincial Governor, through the Provincial Social Welfare and Development Office and in collaboration with other interrelated governmental agencies, shall implement programs, activities and projects to highlight the purpose of this Ordinance. It may include, but not limited to, the following activities:

1. Human Rights Awareness and Consciousness Fora;
2. Host online conference on human rights;
3. Celebrate community awards and recognition;
4. Curate and launch art exhibition;
5. Present advocacy workshops;
6. Publishing researches and quality literature;
7. Sharing information with networks, and speaking to political leaders of solutions on practice-based evidence;
8. Advocates themed events like battle of the bands and concerts;
9. Educate the attendees on human rights events with a panel of experts in the field;

**SECTION 4. APPROPRIATION OF FUNDS.** The Provincial Government shall allocate funds to be utilized in the implementation of this Ordinance.

**SECTION 5. REPEALING CLAUSE.** All ordinances, resolutions and executive orders inconsistent with the provisions of this ordinance are hereby modified or repealed accordingly.

**SECTION 6. SEPARABILITY CLAUSE.** If any part or portion of this ordinance is declared invalid or unconstitutional, other provisions not affected thereby shall remain in full force and effect.

**SECTION 7. EFFECTIVITY CLAUSE.** This ordinance shall take effect after its approval and compliance with the posting and publication requirements.

**UNANIMOUSLY APPROVED.**




