Mayor Denver Reyes Chua tops "Voices of the People" survey

ECSTATIC for receiving a high 88.85 percent rating from the latest survey of RP-Mission and Development Foundation Inc. (RPMD), Cavite City Mayor Denver Reyes Chua thanked his constituents and co-workers in the local city government for their unwavering support and trust that pave the way for making him a top performer in Region 4-A.

"Una po ang pasasalamat ko sa ating Diyos, ikalawa sa aking mga kababayan, inihahandog ko sa inyo ang karangalang ito. Maraming-maraming salamat po sa inyong pagtiwala at suporta sa inyong lingkod," said Mayor Reyes Chua.

Based on the "Voices of the People" study of RP-Mission and Development Foundation Inc. (RPMD) an autonomous, noncommissioned performance appraisal survey conducted on

February 25-March 8, Mayor Denver garnered the top spot among the local chief executives of the provinces of Cavite, Laguna, Batangas, Rizal and Quezon (Calabarzon) in Region-A.

Other top performers were Mayor Eric Africa of Lipa City (Batangas) who came second with 88.13 percent and third placer Mayor Abraham Tolentino of Tagaytay City (Cavite) with 88.29 percent on RPMD's Comprehensive Review of Region 4 City Mayoral Performance.

The awardees were evaluated based on their outstanding performances in the field areas of: service delivery, financial management, economic development, governance and leadership, environmental management, social services, and public engagement.

Other top awardees were: Antipolo City Mayor



Jun Ynares of Laguna -- (87.35 percent; Imus City Alex "AA" Advincula of Cavite--86.64 percent; Santa Rosa City Mayor Arlene Arcillas of Laguna -- 86.48 percent and Batangas City Mayor Beverly Dimacuja of Batangas--85.82 percent.

They were followed by San Pablo City Mayor Vicente Belen Amante of Laguna--84.46 percent; Bacoor City Mayor Edwin

VP Duterte named NTF-ELCAC co-vice chair

IN a press briefing, National Security Adviser retiredGen. Eduardo Ano announced that Vice President Sara Duterte has been named as the co-vice chairperson of the government's anti-communist task force.

Ano said that with the vice president "unstinting commitment in the casue of the National Task Force to End Local Communist Armed Conflict's (NTF-ELCAC)" executive committee has approved Duterte's designation as co-vice chairperson of the anti-communist task force.

Duterte, also known as Inday Sara concurrently

serves as the secretary of the Department of Education (DepEd).

Ano also serves as co-chairperson of NTF-ELCAC.

Ano, a former Interior secretary expressed belief that the vice president's experience as a former local chief executive will prove helpful in fighting the communist rebellion in the country.

"Ang ating vice president ay napaka-well experienced, being a former mayor of Davao

The NTF-ELCAC was created in 2018 during the incumbency of President Rodrigo Duterte, Inday Sara's father.

'Strike' Revilla of Cavite-- 83.81 percent; Calapan City Mayor Marilou Morillo of Oriental Mindoro--81.32 percent; Dasmariñas City Mayor Jennifer Barzaga of Cavite--80.63 percent; and Calamba City Mayor Roseller "Ross" of Rizal-- 77.49 percent.

The results of the Voices of the People survey mirrored the significance of the performance evaluation of city mayors across the Philippines, said Dr. Paul Martinez of RPMD.

"It signifies the importance of evaluations serving as pivotal mechanisms to promote accountability, ensure transparency, facilitate improvement and learning, and foster good governance," he said.

Dr. Martinez added that by systematically appraising the actions and decisions of city mayors, these evaluations hold them answerable to their

Salt can open up opportunities for livelihood in coastal communities

DEPARTMENT of Science and Technology (DOST) undersecretary for regional operations, Engr. Sancho A. Maborang recently graced the "Immersion on Salt Production and Blessing of Salt Facility" activity in Uyugan town in Batanes Province.

The salt production

facility was funded through the DOST's Community Empowerment thru Science and Technology or CEST Program. The project was implemented by DOST - Region 2 led by regional director, Virginia Bilgera in partnership with Mayor Jonathan Nanud Jr. of LGU Uyugan.

U.Sec. Maborang emphasized how salt can open up a sea of opportunities for the livelihood of coastal communities and for the economic growth of an archipelagic nation like the Philippines. He also echoed DOST Secretary Renato U. Solidum Jr.'s commitment

to utilize science, technology and innovation (STI) in reviving the country's salt industry, in line with the agency's mantra of #OneDOST4U.

According to DOST Provincial Science and Technology Centers (PSTCs) Batanes Provincial S&T Director Nora Garcia, the project will further expand and improve livelihood opportunities for residents, especially in the production of the one-day old "dibang" (flying fish) that uses salt as a vital component.

Mayor Nanud Jr. on the other hand, thanked DOST for the assistance provided through the project and assured his support to more initiatives of the department in the municipality.

As part of their exposure visit in the province, DOST 10 staff also joined the activity led by regional director Engr. Romela Ratilla.

"The so-called protracted war must end," she said during a task force meeting in Malacañang.

"This is a show of force — a clear, strong, and powerful statement and warning — against the enemies of the state who slaughter civilians and Indigenous Peoples, abduct and murder and execute members of our security forces, and attempt to pin down our progress as a nation through their ideals anchored on brainwashing, fear, and terrorism," she added.

Human rights group Karapatan, however, slammed the designation of Duterte, describing her as a "serial and notorious redtagger."

Karapatan said that the appointment of Inday Sara "only shows the greater need for the abolition of this TF (task force) that has been responsible for numerous cases of human rights violations."

constituents, thereby strengthening the democratic process.

In his assessment, Dr. Martinez said that these evaluations enhance transparency in public service and they offer a clear, unbiased view into the work of city mayors, making their actions and decisions more understandable and accessible to the public they serve.

"xxx most importantly, these evaluations are the bedrock of good governance. They ensure that city mayors are effective in their roles, fulfill their responsibilities, and ultimately contribute to the betterment of their cities and the nation," Martinez said.

The "Top City Mayors-

Region 4[A] (Calabarzon)" survey was part of the national poll "RPMD's Boses ng Bayan" by RPMD, a nationwide survey performed per district in every region with a total of 10,000 respondents who were registered voters.

The respondents were randomly chosen and the survey a sampling margin of error is ±1 percent with a 95 percent confidence level.
