PH, Israel agree on enchanced agriculture, water management collaboration

THE PHILIPPINES and Israel agreed on a strengthened partnership in agriculture, water management, as well as in establishing direct flights between the two countries, following a meeting on Monday, June 5 by President Ferdinand R. Marcos Jr. with Israeli Foreign Minister Eli Cohen in Malacañang.

Cohen told the President that his country can work with the Philippines on agriculture to ensure food security.

"I think that we can work together on the segment of agriculture. I just let you know that our land, 60 percent of our land

is desert. But although 60 percent of our land is desert, we were able to provide all our water needs," Cohen said, suggesting that the two nations open an agricultural hub to push the initiative.

"And I think that we can work together and let's say that less import, more export for the Philippines. And I think that we can work together."

Aside from agriculture, Cohen said the Philippines and Israel can also collaborate on water management, noting Israel's vast experience in this sector.

Because of water

scarcity, Israel has been reusing large portion of its water resources and it can share its experience in water management with the Philippines, he said, suggesting that an Israeli expert can visit the Philippines to provide advice.

President Marcos said he was glad the Israeli official brought up the issue because agriculture has been the Philippines' priority particularly in improving the economy.

"So, the offers that you make for assistance and partnership in those two areas are very, very welcome," the President

In terms of water management, the Philippines, he said, is looking at Israel and Singapore for best practices that the country can imitate.

In the meeting, Cohen raised the issue of establishing direct flights between the Philippines and Israel to boost tourism and economic ties.

"There's another thing that we, both of us, took for an action item -(it) is to have a direct flight... your external sea between Israel and the Philippines," Cohen said referring to his earlier meeting with Filipino officials. | PND

The court rejected China's claim over nearly the entire SCS as illegal.

Jouble pay for workers on Independence Day

THE DEPARTMENT of Labor and Employment (DOLE) said that employees in the private sector who will report for work on Independence Day on June 12 are entitled to receive "double pay."

According to the DOLE's guidelines, workers are entitled to get 200 percent of their regular

salary for the first eight hours on Monday, a declared regular holiday.

If the employee did not work, he or she shall be paid 100 percent of his or her salary for that day, the guidelines declared.

Also, the labor department said that an additional 30 percent of the hourly rate will be given to worker for work done in excess of eight hours.

Pay rules state that if 12 June is the employee's rest day and he or she still reported for work, he or she shall be paid an additional 30 percent of his or her daily rate of 200 percent.

Also, the rules state

that if the employee worked more than eight hours on his or her rest day on 12 June, he or she shall be paid an additional 30 percent of his or her hourly rate on the day.

Last year, President Rodrigo Duterte signed Proclamation No. 50 which declared Independence Day as a regular holiday.
