SM to open more malls this year

In 2024 another mall will be unvealed in Fujian in China

RETAIL giant SM will open more malls this year, according to its top executive.

SM Supermalls President Steven Tan, said the company will open malls in San Pedro, Laguna and Santo Tomas, Batangas.

He told reporter on the sidelines of the Philippine Retailers Association (PRA) Outstanding Filipino Retailers (OFR) Awards held recently that the Sy family is adding another malls in China where currently it owns 8 malls there.

"The Philippines is a sweet spot of Asia. I would say that because of our population—the new generation—is very young. So there are a lot of brands that are looking into our country, which is a good sign," Tan said during the awards night held recently in Parañaque City.

He said SM will open malls in San Pedro, Laguna and Santo Tomas, Batangas and the company also plans to make its presence felt in some areas in Luzon and Mindanao.

Tan added that SM also will open a bigger mall in

Zamboanga, as well as in Butuan and General Santos Citv.

SM will be everwhere, Tan said and in 2024, the company is planning to construct 5 more malls.

Next year, Tan said that another SM mall will be unveiled in the Fujian province in China.

"As long as there's opportunity and potential, we will open our mall. We will be there," Tan said.

SM Supermalls received a special citation from the PRA during the OFR Awards for its "relentless dedication to support retailers throughout the challenging times of the pandemic."

SM Prime Holdings Inc. president Jeffrey Lim reported in February that its net income in 2022 rose 38 percent to P30.1 billion from P21.8 billion in 2021 on the recovery of its malls.

Consolidated revenues rose 29 percent to P105.8 billion from the previous year's P82.3 billion.



'Free the plant': Alvarez calls to legalize MJ

Shoot them dead!

"SHOOT them dead. Why allow them due process, what for?"

This was the bold statement of former President Rodrigo Duterte when asked what he will do to those police officers who are involved in illegal drugs, saying he sees no reason to allow them to live.

Duterte made the statement over his program "Gikan sa Masa, Para sa Masa" referring to Senator Ronald dela Rosa who heads the inquiry on the 990-kilo shabu hall allegedly involving top tanking police generals, colonels and other commissioned officers.

"Still, until now, it's all investigation. That's how long it's going to take, because that's how the law requires it," Duterte said.

Despite the alleged involvement of some law enforcers in illegal activities, Duterte said, "I love the police."

During his incumbency as Davao City mayor, Duterte acknowleged the big help of the police in providing peace and order in the city.

But he insisted that police officers inbvolved in illegal drugs should be killed.

"xxx you know this is a difficult problem. I have said it before... the best way to deal with these kinds of lawmen: kill them. No need for court proceedings, just kill them," he said.

"Why should I let them live?... due to sympathy to their families? Would it be a redeeming factor? I don't see any," Duterte added.

Over his program, he said: "You are a police officer, but you get yourself into drugs. You want us, the people, to pay you.

From the time you graduated until you reached the situation you are in right now, it's us, the Filipino people, who feed you and your family. And now you want to make a fool of the Filipinos?"

He believe there are police officers who are not just giving protection to the syndicate, "but the officers are the syndicate themselves."

Ober his program, he told the viewers that the country has fractured police force.

"Many hoodlums have entered the police service, even the colonels and the generals. There are many corrupt officers (in the PNP). Maybe one time I will announce the names of those whom I believe are corrupt and involved in drugs," the former president said.

Further, he added that not only generals in Metro Manila are involved in drug syndicates, but they can be found everywhere."

Duterte said that since the police themselves are into drug peddling, it would be difficult to catch them./ **BantayBalita Central Desk**

'Free the plant': Alvarez calls to legalize MJ

FORMER House Speaker and incumbent Davao del Norte Rep. Pantaleon Alvarez reiterated his call to legalize medical cannabis (marijuana), saying it will "help in attaining economic independence and freedom from poverty for our people."

Rep. Alvarez said that by freeing the plant and legalize it but with safeguards, it can harness the full potential of the benefits of Cannabis, both medically and economically.

But the congressman added that medical cannabis should "free the plant" with safeguards.

Alvarez added that what the government need is courage to explore and face the problems head on and let go the negative impression against the

"We need the courage to face the problems head on and the capability to handle the solutions that is called for by modern times," he said.

The government need to take alternative, progressive, yet effective approaches to addressing the country's problems, the former Speaker claimed.

"Decriminalization of Cannabis can lead us to freedom from economic poverty. The potential for economic gain is astounding, international studies and models have proven this," he said.

"The numbers speak for itself, and even our government agencies involved acknowledged it during the technical working group discussions in Congress. We have to face it," Alvarez added.

The legalization of marijuana has demonstrated substantial economic benefits in countries like Canada and the United States, he noted.

In Canada, the cannabis market generated CA\$2.6 billion in sales, while in the United States, it supported over 321,000 jobs and gained US\$18.3 billion in sales.

"Let's roll up our sleeves and embrace the green revolution! By legalizing marijuana, we'll not only light up our economy but also blaze a trail towards prosperity!" Alvarez stressed.

DOST upskills 15 Paglaum women in calamansi juice concentrate processing

MISAMIS Occidental - The Department of Science and Technology (DOST) in this province organized a Skills Training on Calamansi Juice Concentrate Processing for 15 women members of the Paglaum Livelihood Association, May 30, at the Paglaum Learning Site, Plaridel.

The activity included

hands-on training in producing calamansi juice concentrate and orientation on Basic Food Safety and Good Manufacturing Practices (GMP).

DOST also provided the association with kitchen materials and supplies to kickstart the association's venture in calamansi processing.





Joanne Katherine Banaag, the Provincial Science and Technology Director of DOST Camiguin served as the resource person for the hands-on training while Rogelyn Calago of DOST Misamis Occidental guided the participants in basic food safety and GMP.

At the end of the training, the participants were able to produce and package 34 bottles of calamansi juice concentrate and they also experimented on the ideal

concentration for readyto-drink calamansi juice which they aim to market through their catering services.

The participants said the skill they learned from the training will surely help to increase their income and contribute to the economy of the municipality.


This was advisory was posted in the company's social media account.

Altmman proposed the creation of a new regulatory agency that would impose safeguards to prevent AI models from "selfreplicating" and "selfexfiltrating into the wild."

He preferred a body, patterned after the UN nuclear watchdog International Atomic Energy Agency, that would license the most powerful AI systems and have the authority to "take that license away and ensure compliance with safety standards.

The editorial concluded that Altman has sounded the alarm: "It would be tragic if it falls on deaf ears."

A BILL filed at the House of Representatives seeks to increase the number of days that the law grants for paternity leave.

House Bill (HB) 4430, filed on September 5 last year by Quezon City Fourth District Rep. Marvin Rillo, will increase the period of paternity leave with pay

from seven days to 30 days.

It also expands the coverage of the Paternity Leave Act (Republic Act 8187) to include "unmarried fathers who cohabit with the mother without legal impediment to marry."

RA 11210, or the

"Expanded Maternity Leave Law," allows female workers to allocate up to seven days of their maternity leave benefits to the child's father, whether or not he is married to her.

Under HB 4430, a child's father who is legally married to and cohabiting with the mother, is entitled

to seven days paternity leave.

Under Section 2 of RA 8187, a male employee is entitled to a paternity leave

of seven working days with full pay for the first four deliveries "of the legitimate spouse with whom he is cohabiting.'
