Maraming salamat po, UAE Pres, PBBM

... 3 kondenadong Pinoy, pinatawad

NAGPAHAYAG ng malaking pasasalamat ang mga senador sa iginawad na pardon sa tatlong kondenadong overseas Filipino workers (OFWs) sa United Arab Emirates (UAE) sa ginanap na paggunita ng Eid al-Adha.

Sa bisa ng Senate Resolution 665 na iniharap ni Sen. Robinhood Padilla, inihayag ng Senado ang mataimtim na pasasalamat kay UAE President Sheikh Mohamed bin Zayed Al Nahyan sa paggawad ng pardon sa tatlong kondenadong OFWs.

Sa resolusyon, kinilala rin ang malaking tulong ni President Ferdinand 'Bongbong' Marcos Jr. kaya naging a wad ang pagpapatawad sa tatlong kababayang nakapiit sa UAE.

Sa resolusyon, binanggit ang pagsikap ni PBBM na palakasin ang relasyong diplomatiko ng Filipinas at ng UAE at pagtiyak sa mabuting kalagayan ng may 600 libong Filipinong manggagawa sa

naturang bansa.

"Maraming-maraming salamat po sa pardon na iginawad sa tatlo nating kababayang Filipino at ito ay magandang balita sa atin, lalo na at ginugunita ang Eid al-Adha naming mga Muslim," sabi ni Sen. Padilla.

Nitong Abril 27, masugid na umapela si Pres. Marcos sa dalawang ipinadalang sulat sa pangulo ng UAE na patawarin ang mga kondenadong Filipino sa naturang bansa.

Pinatawad ang tatlong OFWs ni Pres. Sheikh Mohamed bin Zayed nitong Hunyo 23, "for humanitarian reasons."

Ayon kay Senate Minority Leader Koko Pimentel 3rd, kapuri-puri ang iginawad na pagpapatawad ng pangulo ng UAE na nangyari dahil sa pagsikap at pakiusap ni PBBM.

"Freedom of the press is a fundamental right here in our beloved country. We can never allow for print to be dead," the senator told PAPI members

Why only me? Gadon says De Lima, Diokno escape SC disbarment

NEW Presidential Adviser for Poverty Alleviation Larry Gadon on Wednesday has questioned the Supreme Court's disbarment ruling against him, asking why other lawyers who committed heavier infractions than him had not faced disciplinary action.

The Supreme Court (SC) announced its decision to disbar Gadon over a viral video showing him uttering profane remarks against a journalist.

The presidential adviser lamented that neither Free Legal Assistance Group (FLAG)

chairman Jose Manuel "Chel" Diokno and former senator Leila De Lima ever got disbarred by the SC.

He cited that Diokno "made a mockery of the Supreme Court proceedings when he filed a petition on behalf of the fishermen who denied having authorized him."

"Diokno falsified the authorization, yet he was not disbarred nor suspended," he said.

Gadon reminded, when she was still justice secretary, De

Lima "defied the SC order allowing PGMA (former President Gloria Macapagal-Arroyo) to travel abroad for medical reasons."

"De Lima admitted illicit, immoral, illegal cohabitation with

her driver, yet the SC did not disbar nor suspend her," he added.

Prior to the SC's announcement of his disbarment, Gadon said he received information about the tribunal's decision.

"The position and the task given to me by the President do not require lawyering hence my

headed by its national president, Nelson Santos.

The Senate recently passed the Creative Industries Development Act which Pimentel himself, authored and championed in the upper House of Congress. "Under this law, RA No. 11904, we are recognizing nine creative domains and it may interest you to know that the 'publishing and printed media domain' is a recognized creative domain. Newspaper articles are journalistic literature," the senator said.

Further, Pimentel cited Section 4 of the 1987 Constitution that says "No law shall be passed abridging the freedom of speech, of expression, or of the press, or the right of the people peaceably to assemble and petition the government for redress of grievances."

He recalled the late Fr. Joaquin G. Bernas, a Jesuit priest, lawyer, college professor and writer who was Dean Emeritus of the Ateneo de Manila Law School, was a member of the 1986 Constitutional Commission which drafted

the 1987 Philippine Constitution, amended a section that says "The right of the people to enjoy freedom of speech and press and to peaceably assemble and petition the government for redress of grievances shall not be abridged."

Pimentel explained that Fr. Bernas pointed out, that by specifying 'people,' it would limit the scope of the protection to natural persons, thus leaving corporate entities, like publishing companies, unprotected.

"I will help you and do whatever I can to contribute to the protection and promotion of the newspaper publishing industry and to news reporting as a whole," Pimentel said.

"As the minority leader in the Senate, I am the designated 'critic' of the majority in the Senate. I need you, for me to be able to perform, competently and credibly, this constitutional duty as Senate Minority Leader," the senator told the publishers, editors, and reporters of national, regional, and provincial

newspapers, present at the occasion.

Other event guests among others, were Judge Judge Flordeliz Cabanlit Fargas of RTC Trece,

In the same occasion, Dayang also launched his book while PAPI members from 1970-1980, Outstanding Court Sheriff 2023 Ms. Joannah Avigail Timkang of RTC Trece Martires and former president and House deputy speaker, Gloria Macapagal Arroyo were honored.

WHY IS THE PHILIPPINES 'RELUCTANT' IN 'LEGALIZING' USE OF MEDICAL CANNABIS?

A known doctor, scientist, researcher, broadcaster lamented that legalizing the use of medicinal cannabis or marijuana still experiences a rough sailing in Congress even if 70 nations are already prescribing this.

Dr. Richard Nixon Gomez, the president of Bauertek Corporation, a research, development and manufacturing company in Guiguinto, Bulacan is also known as "Kaibigan sa Kalusugan."

"Bauertek is one of the most advanced if not the most advanced (pharmaceutical, manufacturer) companies in the Philippines," according to Gomez. He also can be credited for manufacturing one of the known medicines for Covid-19—the Ivermectin as approved by the Food and Drug Administration (FDA).

Gomez was one of the guest speakers at the Publishers Association of the Philippines Inc. (PAPI) 2023 Midyear Executive Session held at the Makati Sports Club last Saturday, June 24. He mentioned that several House bills are now pending in Congress but lawmakers are yet to act on them.

Bauertek is way above

Philippine standards as manufacturer of medical products, supplements and cosmetics. It now has cannabis plantations in various parts of the Philippines and also has facilities to dry the medical cannabis buds, the part used for extracting oil, manufacturing capsule or pills.

Gomez said that countries like Germany, France, Switzerland import cannabis for their medical needs since they do not have the capability to farm the plants on a large scale. "We can produce these and export to them, tax-free," he lamented.

Earlier, Dr. Germ Mutia, founder of Philippine Society of Cannabinoid Medicine, cited the role of medical cannabis in the treatment of various ailments, including epilepsy, Parkinson's disease, depression and those suffering from body pains due to cancer.

He further said that there are currently eight or nine cannabis-related bills pending in Congress, seeking to decriminalize its use. This is aside from a petition reportedly filed by patients or parents of patients to the Dangerous Drugs Board (DDB) to



