SC: best interest of a child can't justify cruel, humiliating punishment

SPOUSES had been found liable for damages for publicly humiliating, harrasing their son's 14-year old girlfriend in a decision released by the Supreme Court.

The High Tribunal said that claiming the best interest of the child is not an excuse to humiliate, belittle, or threaten the child.

"The best interest of a child cannot justify forms of cruel or degrading punishment which conflict with a child's human

PBBM suspends classes in public schools, gov't work in Metro Manila

PRESIDENT Ferdinand R. Marcos Jr. suspended classes in public schools at all levels and work in the government in Metro Manila and in the Province of Bulacan on August 25 to give way for the opening ceremonies of the FIBA Basketball World Cup 2023 at the Philippine Arena in Bocaue, Bulacan.

The memorandum circular no. 27 signed by Executive Secretary Lucas Bersamin on August 15 stated that the suspension of government work and

classes in public schools on Aug. 25 is also part of the government's commitment towards wider involvement and participation in sports promotion and development.

The suspension of government work and classes in public schools is the government's effort to provide full support and assistance to the Philippine Sports Commission (PSC) in ensuring the safe, orderly, and successful opening ceremonies of the FIBA Basketball World Cup

2023.

The President however clarified that government agencies involved in the delivery of basic and health services, preparedness/response to disasters and calamities, and/or the performance of other vital services "shall continue with their operations and render the necessary services."

The suspension of work for private companies and classes in private schools is left to the discretion of their respective heads. | **PND**

dignity, including 'punishment which belittles, humiliates, denigrates, scapegoats, threatens, scares, or ridicules a child,'" the SC Second Division said in its April 26, 2023 ruling.

The SC affirmed the findings of the regional trial court and of the Court of Appeals on the liability of the spouses for their actions toward their son's girlfriend, which had exposed her to public ridicule that caused her "mental anguish, besmirched reputation, wounded feelings, and social humiliation."

The girlfriend was publicly ridiculed calling her as 'makati ang laman,' 'malandi,' and 'hindi matino' in front of her peers, teachers, and parents.

The SC said that this is contrary to the constitutional mandate to defend the right of children, and public policies to

protect their best interest through measures complying with international standards on children's protection.

It said that while parents and legal guardians have the right to provide direction to a child, a child must still be accorded equal and inalienable rights "consistent with the evolving capacities of the child."

The Supreme Court said the parents of the boyfriend could not justify their abusive acts under the pretext of exercising parental authority over their son's 14-year-old girlfriend, as they are not her parents or guardians.

The liable spouses are ordered to pay P30,000 in moral damages, P20,000 in exemplary damages, and P30,000 in attorney's fees and litigation expenses, with legal interest of six percent per annum.

PNHRS unveils updated six-year national health research agenda

The updated six-year National Unified Health Research Agenda (NUHRA) for 2023 to 2028 was launched during the opening ceremonies of the Philippine National Health Research System (PNHRS) week celebration at the Summit Hotel, Tacloban City last 10 August 2023.

In his speech, PNHRS lead coordinator Dr. Jaime C. Montoya emphasized how the agenda "is crucial

in advancing health as it provides a clear direction for research and development and guides better decision-making of health research generators, funders, and end-users."

Spearheaded by the PNHRS Research Agenda Management Committee (RAMC), the updated document is born from 17 regional consultations, and involves inputs from a

variety of research stakeholders.

From these consultations, a total of 170 health research priorities were identified and consolidated into themes and sub-themes. The main themes under the updated NUHRA are as follows: 1) Disease management; 2) Halal in health; 3) Health security, emergency, and disaster risk management; 4) Health technology and

innovation; 5) Health of vulnerable populations; 6) Health promotion; 7) Health systems strengthening towards UHC; 8) Maternal, newborn, and child health; 9) Mental health; 10) Nutrition and food security; and 11) Sexual and reproductive health.

These themes will guide health research efforts in the country from 2023 to 2028.

Dr. Teope said that

"think tank and give suggestions" on the aspect of legalizing the use of medical cannabis which has a rough sailing in Congress even when 60 countries have already approved the use of the medical plant, and counting.

Teope was last Monday's special guest in Bauertek Corporation's weekly Media Health Forum held in Quezon City, hosted by veteran radio broadcasters Rolando 'Lakay' Gonzalo and Edwin Eusebio.

Dr. Richard Nixon Gomez, scientist, inventor and general manager of Bauertek Corporation disclosed that only one patient was given a compassionate special permit by the Food and Drug Administration (FDA) to buy medical cannabis from overseas but to this day, hasn't bought yet due to the whopping price of P1.7 million

for one patient alone.

Gomez said he had been to Sacramento, California some two weeks ago to tour the facility that produces medicine out of marijuana extract. California was the first state to legalize the use of medical cannabis.

He said that the processes were simple but there were those levels they are not capable of doing but Bauertek can do, like

cloning and tissue culture, which the US facility has to outsource.

Other processes include isolation, extraction—all of which Bauertek can likewise do.

Gomez said that many illnesses are covered for treatment by medical cannabis like anxiety, sleep disorder, Parkinson's diseases, cancer, and others.

Teope further explained that

enactment of a law legalizing the use of medical marijuana would mean revenues and taxes for the government while generating job or employment for the people.

The doctor admitted that many Filipinos are "miseducated" regarding the use of medical marijuana, which they say, makes the user an "addict" or "high."

He said there should be education of people on bad and good drugs.

Gomez, on the other hand, proposed for the inclusion of other agencies like the Dept. of Science and Technology (DOST) and the Dept. of Agriculture (DA) in PHILCADA.

Gomez and Teope both believed that those who opposed for the legalization of medical cannabis either "lack education or miseducated."
