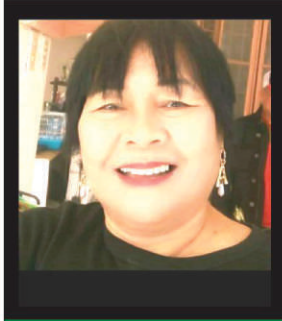

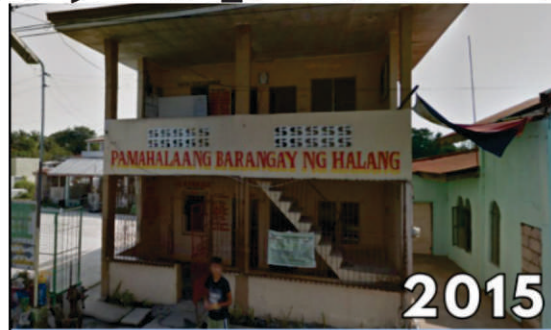

DOST 1 radiates awareness on Global Warming and Climate Change

The Department of Science and Technology Regional Office No. 1 in collaboration with DZAG Radyo Piliinas Agoo took a proactive stance in observance of the Global Warming and Climate Consciousness Week 2023 by conducting its 35th episode of the weekly radio program, "Tekno Presiyensya: SIyensya ken Teknolohiya para kadagiti Umili" on November 23, 2023, via Facebook live which aimed to raise awareness and understanding of critical climate issues among the public.

contributing to global warming. The discussion delved into the extensive ramifications of climate change, including water scarcity, disruptions in food production, threats to health and well-being, impacts on urban infrastructure, and effects on biodiversity and ecosystems.

Ms. Estrebillo presented alarming trends in the Philippine climate, noting an increase in hot days and a decrease in cold nights. Variations in rainfall patterns were highlighted, impacting different regions of the country. While there was a slight decrease in the number of tropical cyclones entering the Philippine Area of Responsibility, an increase in their intensity was noted. The discussion also touched upon the contribution of warming conditions to rising sea levels, particularly affecting islands in Mindanao and the western coasts of Central and Western Visayas.

DOST PAGASA's Climate Information Risk Analysis Matrix (CLIRAM) was introduced as a tool to assist Local Government Units (LGUs) in integrating climate change projections into their local action plans. (Christian Dominic I. Casmiro)

58K worth of Illegal Drugs seized; suspects arrested in a Buy-Bust Ops

Camp BGen Pantaleon Garcia, Imus City -- Cavite Province Police Office chief, Colonel Eleuterio M. Ricardo Jr. announced the arrest of the drug suspects and confiscation of more or less 8.5 grams of suspected shabu in a buy-bust operation conducted by the Operatives of Dasmariñas Component City Police Station in Brgy. San Nicholas 1, City of Dasmariñas, Cavite, on Sunday, December 10.

identified as alias "Jerome," resident of Brgy. Sampaloc 4, and alias "Denjie" of Brgy. San Nicholas 1, this city. The suspects were apprehended after they were caught in the act of selling shabu to a police officer who acted as a poseur buyer. Four (4) pieces of heat-sealed transparent plastic sachet containing crystalline substance were seized from the suspects. The police said that the

confiscated drugs weighing more or less 5.08 grams of suspected shabu has an estimated value of Php 58,650. The suspects have been assessed of the rights and now are under the custody of the Dasmariñas police. Jerome and Denjie were charged for violation of R.A. 9165 or the Comprehensive Dangerous Drugs Act of 2002. Acting Region 4-A police Brig. Gen. Paul

Keneth T. Lucas commended the lead unit and Cavite Police, under the leadership of Col. Ricardo for their notable accomplishments and unwavering effort in intensifying anti-criminality operations against lawless elements within the area of Cavite. Col. Ricardo encouraged the community to be a part of the PNP's efforts. 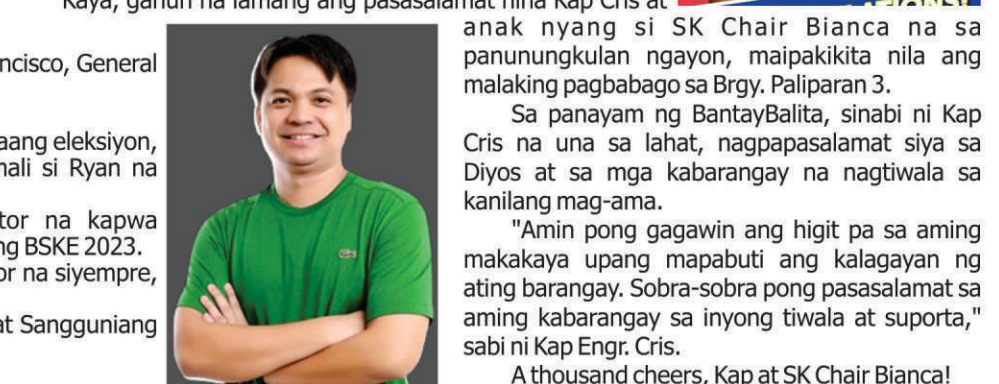


Cavite Provincial Forensic Unit donates blood
