

More than 60 countries allow the use of medical cannabis while the Philippines stands to earn P40billion in yearly taxes when the use of the plant is legalized.

The company's general manager, a scientist and an inventor, Dr. Richard Nixon Gomez, said that legalization of medical cannabis may no longer take long.

"Ilang hakbang na lang po at matitikman na natin ang medical cannabis (as medicine) in the Philippines po," Gomez announced in the forum.

He said a more intense media campaign is necessary.

"Nasa last leg na po tayo ng pakikipaglaban," Gomez added.

Forbes claimed to have used "synthetic medicine for treatement for his 3-year-old daughter who is suffering from stroke and cerebral palsy seizures, since she was one-year-old.

He recalled that his daughter fell into a coma for a day in since then, seizures have been frequent.

He expressed grief that medical cannabis has been proven to cure various illnesses including seizures yet the Philippines seems to ignore this reality while other countries are already into it.

Dr. Gomez said that the Philippines is more than ready to manufacture medical cannabis for treatment for various illnesses and Bauertek Corppration is willing to have a partnership with the government.

Cunanan was grateful to Dr. Gomez for spearheading the information campaign on the benefits of medical cannabis and more people are now enlightened.

Cannahopefuls is optimistic that in the future, Filipinos can use medical cannabis as medicine without fear of being arrested or treated as addict.

## China warns Philippines over WPS sovereignty

China on Monday, October 9 declared that it will do 'what is necessary' to protect its interest in the South China Sea (SCS) or what the Philippines called as the the West Philippine Sea (WPS).

The warning was issued by the Chinese Foreign Ministry as the Armed Forces of the Philippines (AFP) labeled Beijing's recent actions in the SCS, particularly in the WPS as "irresponsible."

The AFO said the actions of China "could lead to its "global

isolation"

The Chinese Foreign Ministry urged the Philippines to take seriously China's concerns.

Beijing also called on Manila to "stop making provocations and creating troubles at sea, and stop groundless attacks and smears."

But China's recent actions in the WPS have been denounced by other countries, including United States, Japan, Australia, the United Kingdom and the European Union.

China had repeatedly

ignored the Philippines' sovereignty over the WPS, despite the United Nations Convention on the Law of the Sea (UNCLOS) and the 2016 Arbitral Ruling, and in sists it has "indisputable" ownership over it and the rest of the South China Sea.

The AFP said it will continue to strengthen its efforts to protect the country's sovereignty over the contested territory by conducting patrol and resupply missions.

The efforts of the Philippines are being countered by China as it take more aggressive actions, such as installing floating obstacles and firing water cannons at Filipino ships.

Beijing said the Philippines" actions in the Ayungin (Second Thomas) Shoal "seriously violate China's territorial sovereignty."

China argued that the Ayungin Shoal "has been China's territory since ancient times," and not of the Philippines "on the grounds of its comparative proximity to Philippine territory."
