Capability Building Event Strengthens Efforts Against Trafficking and Violence in Cavite

More than 60 dedicated attendees comprising members of the Cavite Provincial Committee on Anti-Trafficking and Violence Against Women and their Children (PCAT-VAWC) together with municipal and city social workers from various Local Government Units (LGUs) in the province, gathered on March 13, 2024, at The Bayleaf Hotel in the City of General Trias for a capability building event.

The activity, organized by the Provincial Government of Cavite (PGC) through the

Office of the Provincial Social Welfare and Development Officer, aimed to equip participants with essential knowledge and strategies to combat the pressing issues of trafficking and violence affecting the province's most vulnerable populations.

Mr. Alvin S. Mojica, Provincial Administrator for Community Affairs, set the tone with his insightful opening remarks emphasizing the importance of the Omnibus Guidelines for the Protection of Children Against Violence and Online Sexual Abuse and

Exploitation of Children (OSAEC). He urged all attendees to embrace their role in safeguarding children and echoed the need for collaborative efforts across all LGUs.

Representing Provincial Board Member (PBM) Romel R. Enriquez, chairperson of Sangguniang Panlalawigan (SP) Committee on Women, Family, Children, Elderly and Social Services, Ms. Marife V. The discussion sessions were led by distinguished speakers who provided comprehensive understandings and expertise.

DOST provides temperature calibration services to RHU Manticao



In support of Misamis Oriental's immunization programs, the Department of Science and Technology (DOST) provided free temperature calibration services to the Rural Health Unit (RHU) of the Municipality of Manticao on February 21, 2024.

Regional Metrology Laboratory staff Engr. Delwin M. Balanay Jr. and Engr. Shane Marie S. Clavano calibrated the thermometers or temperature sensors of the three bio refrigerators, two refrigerators for laboratory specimens, one unit Freezer thermometer, one unit room thermometer, and

14 units of Vaccine Carrier Digital Thermohygrometers.

Calibrating the thermometers is crucial in ensuring the viability of specimens and the efficacy of the vaccines. RHU Manticao conducts vaccination for COVID-19 vaccines and the Routine

National Immunization Program for its different barangays.

The total value of assistance provided to the LGU through these services amounted to Php 35,150.00.

Dr. Eddy Paul L. Mallillin, the Municipal Health Officer, thanked

DOST.

"We appreciate and are grateful to DOST 10 for considering and accepting our request. Ensuring and maintaining vaccine efficacy is one of our priorities. In addition, we always make sure that our equipment is calibrated annually. With

Btr: PHL '22 debt payments reach P1.293T

The Bureau of Treasury (Btr) announced that the Philippines' debt service payments last year amounted to P1.293 trillion, the highest in 36 years.

The data said that prior to 2022, the largest debt payment was recorded in 2021 while the lowest was posted in 1986, when it reached P34.813 billion, based on existing government data.

higher than the P1.2 trillion posted in 2021. The data said that prior to 2022, the largest debt payment was recorded in 2021 while the lowest was posted in 1986, when it reached P34.813 billion, based on existing government data.

However, the debt service payments last year were slightly lower than the initial target of the government. For 2022, the government programmed debt payments to reach P1.298 trillion.

BTr data indicated that amortizations rose 2.02 percent to P790.32 billion in 2022 from P774.64 billion in 2021.

In December, debt service payments soared 331.67 percent to P302.125 billion in 2022 from the P69.989 billion posted in 2021.

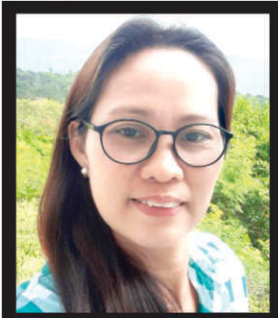
