# Robin Padilla endorses July 27 Holiday in honor of Iglesia Ni Cristo's contribution to nation

Senator Robin Padilla backs the declaration of July 27 as a non-working holiday to recognize Iglesia Ni Cristo's (INC) patriotism and monumental contributions to the nation over the past century.

Senator Robin Padilla is calling for a nationwide celebration to honor the patriotism and monumental

contributions of the Iglesia Ni Cristo (INC) to the nation.

According to Padilla, the proposed non-working holiday on July 27 aims to give the nation the opportunity to commemorate the religious group's legacy and societal impact over the past century.

The influential religious group led by Executive Minister

Eduardo Manalo marks its 110th founding anniversary on July 27.

The proposal was raised during a Senate hearing of the committee on constitutional amendments chaired by Padilla on Monday.

As he paid tribute to the group's nation-building efforts, Padilla highlighted the INC's global reach and diverse

membership.

Padilla said he has been a witness to the INC's "godly mission" here and abroad with members demonstrating their steadfast patriotism and concern for their fellowmen.

Kasama ang grupong Pamalakaya at Kadamay, inihain ng mga miyembro ng Makabayan bloc ang House Resolution (HR) 1653 para atasan ang mga kinauukulang komite na imbestigahan ang mga sunog na ito.

Una nilang nasunog ang Coast Community sa Barangay Medicion 2-B sa Imus, Cavite noong Enero 17 kung saan may 11 pamilya ang naapektuhan at noong Pebrero 8, ay nagkaroon naman ng sunog sa Brgy. Aniban 3 sa Bacoor City.

May 50 pamilya naman ang naapektuhan nang



magkaroon ng sunog sa Brgy. Pulvorista sa Kawit, Cavite noong Pebrero 9 at kinabukasan, Pebrero 10, ay 91 pamilya naman ang nasunogan sa Manggahan St., Brgy. Niog I, Bacoor City.

Matapos ang isang linggo, o noong Pebrero 17, nagkaroon ulit ng sunog sa Niog I, Bacoor City kung saan 50 kabahayan ang natupok at 328 residente ang naapektuhan habang noong Pebrero 24, nagkasunog din sa Brgy. Alima, Bacoor City.

Gayundin sa Brgy.

Talaba, Bacoor noong Pebrero 27, habang nito lang Marso 5 ay nasawi ang may 4 residente sa Brgy. Biwas, Tanza matapos ding magkasunog.

"Whereas, most of the affected urban poor and coastal communities are covered by various infrastructure and reclamation projects. These projects include the Manila-Cavite Toll Expressway (MCTEX) in five towns, and the 420 hectares reclamation in Bacoor City," ayon sa resolusyon.

only lead to additional revenue for the government but will also provide convenience to passengers by increasing the facility's current passenger capacity from 35 million a year to 62 million annually.

The agreement was signed by Department of Transportation (DOTr)

Secretary Jaime Bautista, Manila International Airport Authority General Manager Eric Ines, and San Miguel Corporation (SMC) President and Chief Executive Officer Ramon Ang

The project, Malacanang said,, initially covers 15 years

and could be extended by 10 years.

The consortium is composed of San Miguel Holdings Corp., RMM Asian Logistics, Inc., RLW Aviation Development, Inc., and Incheon International Airport Corp.

Once the NAIA modernization is

complete, its runway capacity will increase by at least 48 air traffic movements at the peak hourly rate.

The project is expected to generate P900 billion of earnings for the national government or about PHP36 billion annually throughout its full 25-year concession period.

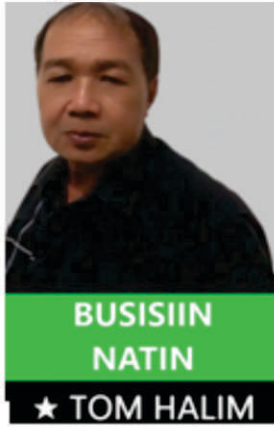

And the rest is history, so to speak and St. Gilbert Myra Academe, Inc. since then had been permitted to operate by the Department of Education (DepEd).

"Ang atin pong school ay recognized ng DepEd dahil na-meet natin ang lahat ng requirement, at nakita na qualified ang standard program natin, magagaling ang faculty, we have the necessary facilities para mabigyan ng quality education ang ating mga estudyante," Ms. Myra.

At present, SGMAI has a Pre-School Department, Grade School Department and High School Department.

One highlight of the celebration was the coronation of the Mr. and Miss SGMAI participated in by 14 Kinder and Grade School students.

These wonderful children and their parents contributed to the excitement and joy during the celebration of such a special event.

I was teary-eyed when Ms. Myra acknowledged that I have been a part of the Academe's history for nearly 10 years since its creation.

To me, the SGMAI is such a special school community. I talked to a few teachers and they told me of their sacrifices during the stime the SGMAI started from a kinder school and became a separate grade school and soon became a primary academy in the GenTri City.

A teacher said that the celebration was an 'emotional' event for the staff, saying they were able to survive during the pandemic years and how the students and the parents worked hard as a united and whole school community together that at present, despite the financial difficulties, "we are marking this occasion as a gift of love and protection for the future generation."

The SGMAI is giving special discounts to poor parents so that their children could continue their studies in the academe.

"Ayaw natin na matigil ang mga bata sa kanilang pag-aaral dahil lang sa kahirapan, kasi kami dito sa SGMAI ay naniniwala, education is a human rights. Kaya kami rito, we give scholarship sa matatalinong bata," Ms. Myra said.

She said she is very proud of the faculty for their sacrifices and to the able leadership of Principal Angelita Victorino and the Board of Directors for their steadfast commitment to give quality education for their students.

"Siyempre, I am proud and thankful to the parents, sa kanilang cooperation at pagtiwala sa ating paaralan. And to the children, nakakatuwa na makita ang kanilang excitement sa ating events," Ms. Myra M. Magnin told BantayBalita.

I thank my co-judges Pastor Rick Ocampo, Ms. Jessah Carreon, team leader of Kinder for we had a hard time to choose the winners of the Mr. and Miss SGMAI.

BantayBalita is proud to have been part of this year's celebration and we hope to be a part of it next year's milestone in giving the quality education to SGMAI learners.
