

# "Legalize use of medical cannabis," a doting father appeals to Congress

An adoring father has emotionally appealed to Congress to now approve the use of medical cannabis or marijuana as medicine, for the sake of his only son and other patients.

Romeo Ballesteros, a member of Cannahopefuls, Inc. – an advocacy group for the legalization on the use of medical cannabis, was teary-eyed when he appeared before the weekly Media Health Forum of Bauertek, Inc. last Monday.

That was the reason why the alleged irregularities in Congress' use of public funds aren't publicized, FPRRD said on his show on SMNI Tuesday, October 17.

Duterte dismissed

the earlier statement of ranking lawmakers from the House of Representatives that the COA found no red flags in the chamber's spending.

## Seafarer's family seeks Justice for kin's death

The family of a 39-year-old seafarer who died due to overwork, lack of rest, and on the job in extreme condition in a bulk carrier anchoring in an UAE city are asking the Department of Migrant Workers (DMW) and its attached agency, the Overseas Workers Welfare Administration (OWWA), to conduct a serious and thorough

probe of incident.

The victim, Alberto M. Coletto, a native of Tago, Surigao del Sur, had just woke up from a short, two-hour rest when he collapsed and given emergency treatment before he expired.

Prior to this, he was working 38 long hours with only 2-hour break in a scorching environment, doing exhaustive cleaning and sweeping inside Star Gwyneth, a bulk carrier.

Testimonies of fellow workers showed that Coletto was ordered by the operator to work in a scorching workplace during the vessel's port of call in Mina Saqr, United Arab Emirates, before being allowed to take a breather.

News of the death of Coletto was conveyed to StarOcean Manning, Inc., his agency, which in turn reported the tragedy to Mary Grace Coletto-Salinas, the victim's sister.

Family spokesman Bon Salinas, victim's brother-in-law, said the family is not satisfied over the explanation given by the agency, saying the account was not transparent and detailed, especially on the circumstances that led to Albert's death.

Salinas said the family is seeking justice by filing appropriate civil and criminal charges against the ship operator and the manning agency for neglectful and remiss acts, and against the individuals tasked to make the workplace safe and secure.

He said they are also looking to the possibility that lack of safeguards and precautionary protections contributed to his demise.

Though DMW and OWWA have made their own separate probes to get to the bottom of the case, the victim's family want the inquiry done speedily to the satisfaction of Albert's family, and to carry out the suitable penalties for whosoever is to blame for the preventable misfortune. / MANNY TOMANAO

Duterte added: "Hindi in-audit ang Congress. Not once, not twice, not at all."

He said that despite the strict accounting rules, Congress cannot be penetrated.

He challenged the COA to expose how members of Congress spent the taxpayers' money during the past years.

"Wag na tayong mag-debate, just open the books, no more talk. Show us where the money is and how

Sachi has been suffering from seizure disorder since he was five months old.

Studies, research and clinical trials show that medical cannabis can cure epilepsy and other ailments.

It has also been clinically proven for chronic pain, chemotherapy associated nausea vomiting, multiple sclerosis, among others.

Medical cannabis' use is legal in 60 countries and counting.

The Philippine Senate and House of Representatives have yet to approve the legalization of its use.

Dr. Gem Marq Mutia, an adult medicine specialist and founder of Philippine Society of Cannabinoid Medicine, a regular forum panelist said that patients and parents from overseas who gave testimonies on the benefits of medical cannabis, are the reason why local patients have as well, appealed to legalize its use.

Dr. Richard Nixon Gomez, an inventor, a scientist and general manager of Bauertek, Inc. said that they are looking forward for Congress' approval before the end of 2024.

The elder Ballesteros said that his son is currently taking five anti-epileptic drugs but these have side effect on the boy's immune system and caused other medical problems "that affect his quality of life."


He added that this is also the reason, they can't send Sachi to a regular school.

Dr. Mutia has called on Congress and leaderships of other medical groups not to make it difficult to patients and their parents who want to try and "possibly, it's a very effective option."

He said, it's also hard to acquire compassionate special permit to avail of imported drugs made from medical cannabis.

It was only in 2016 when CBD use was approved by Food and Drug Administration (FDA) because there were those who tried to get it via "underground" but found the compound to be effective.

## Ilocos region celebrates RSTW 2023 in Laoag City

He added that these activities aim to promote and disseminate STI products and information that can help improve the quality of life of the people and communities and create livelihood opportunities for their growth.

"We have also

sustained and further strengthened the implementation of our major programs in the regional operations, such as the Small Enterprise Technology Upgrading Program (SETUP), Smart and Sustainable Communities Program and Community Empowerment through Science and Technology (CEST), and we look forward to implementing more initiatives," Solidum said.

In his speech, DOST Undersecretary for Regional Operations, Engr. Sanchez A. Mabborang said that the agency's programs work toward harnessing STI towards wealth creation.

## PGC Budget Hearing: Examining the 2024 Proposed Local Expenditure Program



The Provincial Government of Cavite (PGC) through the Sangguniang Panlalawigan Committee on Finance, Budget and Appropriations chaired by Board Member Aidel Paul Belamide, spearheaded the two-day hearing on The Proposed 2024 Local Expenditure Program.

The first hearing was conducted on October 9, 2023, at the Sangguniang Panlalawigan Session Hall in Trece Martires City, and the second hearing on October 12, 2023 at Anya Hotel, Tagaytay City.

The first leg of the hearing on October 9 was presided by Vice Governor Athena Tolentino with Board Member Maurito Sison who delivered the opening remarks.

Proposed expenditure programs of offices under the Social Services cluster of the PGC including the provincial hospital, Cavite Center for Mental Health and other satellite hospitals were

presented and reviewed as well as those of the Office of the Provincial Social Welfare and Development Officer, and the Office of the Provincial Population Officer.

On the second day of the hearing, Governor Jonvic Remulla joined the provincial board and the heads of the different departments of the PGC in the review of the proposed local expenditure program for the General Public Services and Economic Services sectors.

After thorough rounds of presentation of the accomplishments, plans and budget of all the offices, the program successfully concluded with a closing message delivered by Board Member Reyniel Ambion.

The two-day hearing highlighted the transparent and prudent use of provincial government's resources aimed at delivering effective and efficient public service for all Caviteños. —OPPIO

**Sen. Imee distributes aid to individuals in crisis situations**

Dasmariñas City — Senator Imee Marcos led the distribution of assistance to individuals in crisis situations (AICS) in this city which was facilitated by the Department of Social Welfare and Development (DSWD) on Wednesday, October 18.




## Imus City prepares for BSKE 2023
