mga aplikante.



media, Cavite Provincial Police Office (CPPO) chief, Colonel Eleuterio M Ricardo Jr. identified the suspects as alias "Boy," resident of Brgy. San Antonio, Cavite City, Cavite (Street Level Individual), alias "Tomboy," of Brgy. Panapaan 4, Bacoor City, Cavite (Street Level Individual) and alias "Ramir" resident of Brgy. 47, Cavite City, Cavite (Street Level Individual).

Seized from the suspects were four (4) heat sealed transparent plastic sachet containing white crystalline substance suspected shabu, cellular phone, white pouch and buy bust money.

The confiscated items weighing more or less 25 grams were estimated to have a street value of Php172,500.

The seized illegal drugs are now with the Cavite Provincial Forensic Unit in Imus City.

Case of violation of R.A. 9165 are now being readied against the suspects.

For this latest accomplishment against illegal drugs trafficking, police Brig. General Paul Kenneth T Lucas, acting PNP Region 4-A director has commended the CPPO leadership under police Colonel Eleuterio M. Ricardo Jr.
