Comelec disqualifies Smartmatic

COMMISSION on Elections (Comelec) Chairman George Erwin Garcia announced Wednesday Nov. 29 that the poll body has approved the resolution disqualifying technology provider Smartmatic Corp. (Smartmatic) from participating in all bidding and procurement processes of the commission.

The petition to disqualify Smartmatic was filed in June by former Information and Communications Technology Secretary Eliseo Rio, former Comelec Commissioner Augusto "Gus" Lagman, Franklin Ysaac and Leonardo Odono.

The petitioners cited "serious and grave irregularities in the transmission and receipt of election returns" in the 2022 national elections, claiming that there were irregularities between the transmission logs and reception logs from the precinct level to the Comelec's transparency server.

Smartmatic has won all the biddings of the Comelec since 2010 when it first bagged the election automation project.


Imus Free Concert

Sen. Revilla files SB 2492 to provide general declaration of PH maritime zones

NOW is the time to legislate a law that would define the Philippines' own maritime territory.

This was declared by Senator Ramon "Bong" Revilla Jr. the principal author of Senate Bill No. 2492 (The Philippine Maritime Zones Act) amid the increasing maritime security threats in the West Philippine Sea (WPS).

In a statement released recently, the Caviteño senator said the country must be spared from bullying within its own maritime territory.

Revilla said that SB 2492 provides for a general declaration of the maritime zones under the Philippines' jurisdiction, including its internal waters, archipelagic waters, territorial sea, contiguous zone, exclusive economic zone, and continental shelf.

In the bill, the senator said that the law would define the maximum extent of the territorial sea (12 nautical miles), contiguous zone (24

nautical miles), EEZ (200 nautical miles), and continental shelf, and allow the delineation of continental shelves extending beyond 200 nautical miles, in accordance with the United Nations Convention on the Law of the Sea.

If passed into a law, the Philippines would establish its exclusive right to explore and exploit living and nonliving resources found in these zones, said Revilla. /ETII

ROSARIO town has a new ambulance that it could use during disaster, in transporting patients to hospitals and other emergencies.

During the turn-over ceremony, Cavite District 1 Rep. Jolo Revilla said that the donation was made possible through his cooperation with the Department of Health (DOH) to ensure that there would be adequate, proper, and good quality medical services for people in his district.

Rosario Mayor Voltaire Ricafrente thanked Revilla

Speedboat Innovator receives Industry 4.0 iREADY Award from DOST

A SPEED boat innovator in Cagayan de Oro City, Misamis Oriental receives an award from the Department of Science and Technology (DOST) as the agency's most industry 4.0-ready assisted MSME.

This national-level recognition, dubbed as the iREADY award, was received by AJIS Dive and Aqua Sports Inc. on November 22, at the National Science and Technology Week celebration opening ceremony in Iloilo City.

The iREADY award is a nationwide award by DOST that aims to recognize MSMEs that are poised to adopt Industry 4.0 technologies in their operations.

The readiness index was determined based on the following readiness pillars: organization, data, hardware, software, and people. A cash reward of Php 100,000.00 was awarded to the firm.

As the pioneer fiberglass speed boat manufacturer in Northern



Mindanao, AJIS has been using various technologies in their daily operations to produce quality boats that are now being sold in various parts of the country, such as Manila, Cebu, Palawan, Tawi-tawi, and more.

In their production facility in Opol, Misamis Oriental, the firm uses an established process in their data collection as part of their data quality practices and follows an IT security protocol for data protection. AJIS also utilizes a production planning

software integrated with other softwares for more efficient and systematic operations. The firm also aims to use Radio Frequency Identification, 3D scanners and more advanced technologies in the next five years, said Mr. Allan Sagrado, the firm's president.

The firm received its first DOST assistance in 2019 through the Small Enterprise Technology Upgrading Program (SETUP), to which they acquired a 2-Axis CNC Router with Rhino 3D Software

- a computer-controlled cutting machine for different types of surfaces.

The CNC Router machine enabled the firm to significantly improve the quality of their boats, especially for 17 and 36-footer speed boats and yachts.

"Thank you DOST for helping us build our dream boats. We will never stop dreaming," he said.




