Sa botong 126 na pabor, 109 na kontra at 20 na umiwas bumoto, inokeyan ng House of Representatives ang panukalang batas upang maipatupoad ang absolute divorce sa Pilipinas.

Umaasa si Albay Rep. Edcel Lagman -- mayakda ng panukalang Divorce Bill (House Bill 9349) -- na may katulad ding panukalang batas na pagtitibayin ng Senado, ito ay upang "makalaya sa gapos ng masamang pagsasama ang mga dina-mapagkakasundo at matagal nang hiwalay at nagkakasakitang magasawa."

Ito ang ilan sa mga kondisyon at batayan upang maigawad ang absolute divorce:

- -- mga batayan para sa legal separation na isinasaad sa Article 55 of the Family Code.
- -- mga batayan para sa annulment of marriage, ayon sa Article 45 of the Family Code
- kung sa loob ng lima (5) o higit pang mga taon ay matagal nang magkahiwalay sa pagsasama ang magasawa at imposible na ang sila ay muling magkasundo at makapagsimula na muling magsama.
- sinoman sa magasawa ay may tinataglay na psychological incapacity.

- -- kung ang isa sa mag-asawa ay sumailalim sa sex reassignment surgery o pagpapalit ng kasarian, ibig sabihin, ang lalaki ay nagpaopera upang maging babae, at ang babae ay dumaan din sa surgery upang maging lalaki.
- -- kung ang mga kondisyon at mga insidente magpapatunay na imposible na ang muling pagkakasundo ng kasal na maq-asawa.
- -- kung nangyayari ang maraming insidente at uri ng pisikal, emosyonal at sexual na pag-abuso.

Ayon sa panukala, inaatasan ang Department of Social Welfare and Development (DSWD) na pangunahing ahensiya magpapatupad sa batas diborsiyo.

# Sen. Bong Go: Honest governance key to economic development Congrats Silang LGU! Salamat sa komento, mga giliw naming mambabasa, at ito ay aming ipararating

During the hearing conducted by the Senate Committee on Constitutional Amendments and Revision of Codes (Subcommittee on Senate Resolution of Both Houses No. 6) in Baguio City, Friday May 17, Senator Christopher "Bong" Go pointed out that attracting foreign investments involves much more than simply removing constitutional limitations.

He cited a study by the Philippine Institute for Development Studies (PIDS), which argues that effective and honest governance is the key to economic development.

"Merong pong pagaaral din ang Philippine Institute for Development Studies, saying na what is required in the Philippines to bring in foreign investment is not only lifting whatever restrictions, but in good governance po and eradicating corruption," Sen. Go said.

To address this concerns, Sen. Go has filed Senate Bill No. 194, or the E-Governance Act which aims to create a comprehensive digital infrastructure, integrating an extensive



communications network that spans all levels of government, an internal records management system, an information database, and digital portals for public service delivery.

With regards to the




