ORDER

Before this Court is a Petition for the accreditation of Bantay Balita Newspaper Publishing, filed by its publisher, Domingo B. Caoile.

In the Order of the Court dated November 24, 2023, the petitioner was directed to submit a bonañide list of its paying subscribers.

On December 11, 2023, the petitioner through its representative, submitted a Compliance. Attached thereto are copies of the official receipts of payments from its subscribers.

The petitioner was able to present the original copies of the relevant Annexes of the Petition, during the hearing held last November 24, 2023 and through the above-mentioned Compliance.

As per the Sheriff's Report, dated November 21, 2023, the petitioner is indeed holding its office at Block 2 Lot 27 Camella Barcelona Phase 1, Buhay na Tubig, Imus City, Cavite.

After then a perusal of the allegations of the Petition and its annexes and taking into account that the petitioner apparently is duly registered with the Department of Trade and Industry; it is edited, published, and circulated within the Province of Cavite; the herein newspaper has been regularly published for at least one year before the date of the of the application for accreditation; it is not participating in the raffle of judicial notices in other provinces or cities outside Cavite; and considering further the compliance with the other provisions under

A.M. No. 01-1-07-SC, dated October 16, 2002, Re: Guidelines in the Accreditation of Newspapers and Periodicals Seeking to Publish Judicial and Legal Notices and Other Similar Announcements and in the Raffle thereof, the Court **GRANTS** the said petition.

WHEREFORE, Bantay Balita Newspaper Publishing is hereby accredited and authorized to participate in the weekly raffle of legal and judicial notices issued by this Court.

The accreditation shall be valid for a period of five (5) years from the date hereof unless revoked or suspended in accordance with Section 16 of A.M. No. 01-1-07-SC.
