# PH, China agree to combat crimes related to POGOs

The governments of the Philippines and China have agreed to explore ways to address the escalating issues associated with POGOs, including human trafficking and other

criminal activities, said the Philippine Anti-Organized Crime Commission (PAOCC) on Tuesday July 2.

This happened after Ambassador to the Philippines Huang Xilian met Executive Secretary Lucas Bersamin who also head the PAOCC, on Monday, July 1.

PAOCC said that China expressed its appreciation for the recent actions taken by

the Philippine law enforcement authorities to counter illegal offshore gambling and to rescue several Chinese nationals.

Authorities from the two nations reviewed the legal and regulatory frameworks governing POGOs in the Philippines, aiming to strengthen enforcement mechanisms against illegal activities.

Also, China has

committed to assisting in the deportation of Chinese nationals involved in illegal POGO operations.

Bersamin emphasized the importance of this collaboration, noting that POGO-related crimes have led to numerous social problems, including

increased rates of kidnapping, prostitution, and human trafficking.

The issue of POGO-related crimes has been a significant concern for both countries, with the Philippines recently deporting Chinese nationals involved in illegal activities.

**AN ORDINANCE AMENDING PROVINCIAL ORDINANCE NO. 369-2022 ENTITLED, AN ORDINANCE ADJUSTING THE MINIMUM MANDATORY FEE SCHEDULE OF PROFESSIONAL FEES FOR PATHOLOGISTS**

**WHEREAS**, Section 131 (l) of the Republic Act No. 7160, otherwise known as the Local Government Code of 1991, defines “Fee” as a charge fixed by law or ordinance for the regulation or inspection of a business activity;

**WHEREAS**, Section 18 of the same Act provides in part that local government units shall have the power and authority to create their own sources of revenue and to levy taxes, fees and charges which shall accrue exclusively for their use and disposition and which shall be retained by them;

**WHEREAS**, Section 132, of the same Act likewise provides in part that the power to impose a fee shall be exercised by the sanggunian of the local government unit concerned through an appropriate ordinance;

**WHEREAS**, Section 468 (a) (1), of the same Act provides in part that the Sangguniang Panlalawigan, as the legislative body of the province, shall approve ordinances and pass resolutions necessary for an efficient and effective provincial government;

**WHEREAS**, there is a need to adjust the minimum mandatory fee schedule of professional fees for pathologists as prescribed under Board Resolution 2022-008, of the Philippine Society of Pathologists, Inc., issued on 30 May 2022, which shall be implemented through an ordinance;

**WHEREAS**, the 11th Sangguniang Panlalawigan of Cavite enacted Provincial Ordinance No. 369-2022, An Ordinance Adjusting the Minimum Mandatory Fee Schedule of Professional Fees for Pathologist, during its 14th Regular Session held on 24 October 2022;






