PROVINCIAL ORDINANCE NO. 455-2024

AN ORDINANCE INSTITUTING FREE QUALITY ORAL HEALTH PROGRAM IN THE PROVINCE OF CAVITE

Introduced by: Hon. Kerby J. Salazar Sangguniang Panlalawigan Member, 6th District

Sponsored by: Hon. Reyniel A. Ambion Chair, Committee on Health, Nutrition and Population

and

Co-sponsored by: All Sangguniang Panlalawigan Members

WHEREAS, as mandated by Art. 13, Sec. 11 of the 1987 Philippine Constitution, the State shall adopt an integrated and comprehensive approach to health development which shall endeavor to make essential goods, health and other social services available to all the people at affordable cost. There shall be priority for the needs of the under-privileged, sick, elderly, disabled, women, and children. The State shall endeavor to provide free medical care to paupers;

WHEREAS, pursuant to the same constitution, the State shall establish and maintain an effective food and drug regulatory system and undertake appropriate health, manpower development, and research, responsive to the country's health needs and problems;

WHEREAS, pursuant to the Republic Act No. 11223, otherwise known as the "*Universal Health Care Act*", it is the policy of the State to protect and promote the right to health of all Filipinos and instill health consciousness among them;

WHEREAS, Proclamation No. 559, s. 2004, declares the month of February of every year as National Oral Health Month;

WHEREAS, a month-long celebration of National Dental Health Month (NDHM) every February serves as an opportunity to educate the public about the importance of oral health, preventative measures to maintain healthy teeth and gums, and the significance of regular dental check-ups;

WHEREAS, the Provincial Government of Cavitedeems it necessary to institute a comprehensive approach to oral health promotion, prevention, and care, ensuring that individuals and communities have the knowledge and resources needed to maintain optimal oral health of people in the Province of Cavite;

WHEREAS, the National Oral Health Survey (NOHS) conducted last 2018 showed that 72% of Filipinos are suffering from dental caries



or tooth decay while 43% have periodontal diseases. Based on the Oral Health Consolidated Report of 2023, 77% of Cavitenos are inflicted with dental caries and 7.3% have gum problems.

WHEREAS, oral health is a vital component of overall wellbeing, extending far beyond the aesthetics of smiles. It plays a fundamental role in maintaining the general health and directly influences various aspects of daily lives, including the ability to eat, speak, and enjoy a high quality of life.

NOW, THEREFORE, on motion of Hon. Salazar, duly seconded by Hon. Enriquez, Hon. Jaro, Hon. Remulla, Hon. Ambion and unanimously approved by the Members present, be it enacted by the Sangguniang Panlalawigan of Cavite in a session duly assembled that:

- **SECTION 1.** Short Title. This ordinance shall be known and cited as "Ngiting Kabitenyo Ordinance."
- SECTION 2. Declaration of Policy. It is hereby declared that it is the policy of the Provincial Government of Cavite to provide free quality, safe, and accessible oral health programs for the people of Cavite.
- SECTION 3. Definition of Terms. As used in this Ordinance, the following terms shall mean:
 - (A) ORAL HEALTH WORKSHOPS shall refer to educational workshops in communities to raise awareness about the importance of oral health, proper brushing and flossing techniques, and the impact of diet on dental health.
 - (B) COMPREHENSIVE ORAL HEALTH **TREATMENT** – shall refer to the dental services to be provided to the underserved areas, general public, schools, workplaces to improve access to care but not limited to Fluoridation Programs, Sealant Programs, Regular Check-ups and Cleanings, and tooth extraction.
 - (C)ORAL HEALTH POSTER AWARENESS CAMPAIGN - shall refer to a month long dissemination of posters to underserved areas, general public, schools, workplaces about oral health awareness every February in accordance to Oral Health Month pursuant to Presidential Proclamation No. 559 series of 2004.
- Cavite aims to achieve the following purposes.
 - (A) To implement measures to prevent oral diseases, such as dental caries (cavities) and periodontal diseases, through community-wide preventive initiatives.
 - (B) To raise awareness about the importance of oral health through educational campaigns targeting the general public, schools, workplaces, and healthcare settings.
 - hygiene practices, including regular tooth brushing, flossing, routine dental check-ups, and tooth extraction.
 - (D) To promote nutrition education and policies that support a healthy diet, as diet plays a significant role in oral health.
 - (E) To facilitate collaboration between oral health

- professionals, public health agencies, educational institutions, and community organizations to address oral health comprehensively.
- (F) To engage the community in the development and implementation of oral health policies to ensure that interventions are culturally sensitive and responsive to

SECTION 5. Administrative Provisions.

- (A) The Office of the Provincial Health Officer in coordination with all cities and municipalities, shall spearhead the observance of the National Oral Health Month every February.
- (B) The Provincial/ City/ Municipal Health Offices shall develop and implement educational campaigns focused on oral health, addressing topics such as proper brushing techniques, the importance of regular dental check-ups, and the impact of diet on oral health.
- (C) The Provincial/ City/ Municipal Health Offices shall collaborate with schools to conduct oral health programs, including workshops, presentations, and activities aimed at educating students about maintaining good oral hygiene.
- (D) The Provincial/ City/ Municipal Health Offices shall arrange for dental health professionals to offer free or discounted dental check-ups at community centers, health clinics, or mobile dental clinics during Oral Health Month.
- (E) The Provincial/ City/ Municipal Health Offices in partnership with the community center shall distribute posters to the general public, schools, workplaces, and healthcare settings highlighting key oral health messages, tips, and contact information for local dental services.
- (F) The Provincial/ City/ Municipal Health Offices shall create a partnership with dental schools or training institutions to involve dental students in community outreach activities, providing both education and services.
- SECTION 4. General Objectives. The Provincial Government of SECTION 6. SEPARABILITY CLAUSE. If, for any reason/s, and part/s or provision/s of this Ordinance shall be declared unconstitutional or invalid, other part/s or provision/s hereof not affected hereby, shall remain in full force or effect.
 - **SECTION 7. REPEALING CLAUSE.** All ordinances, resolutions and executive orders inconsistent with the provisions of this Ordinance are hereby repealed or modified accordingly.
 - To encourage and support the adoption of proper oral **SECTION 8. EFFECTIVITY CLAUSE.** This ordinance shall take effect after its approval and compliance with the posting and publication requirements.
