Bacoor Assembly of 1898 Act passes Senate 3rd and final reading

Cavite second District Representative Lani Mercado-Revilla lauded the Senate's passage on the third and final reading of the proposed Bacoor Assembly of 1898 Act.

In 2013, Rep. Mercado-Revilla filed House Bill 7896, An Act Declaring August 1 of Every Year A Special Working Holiday to be known as the "Promulgation of the Solemn Declaration of Philippine Independence."

The Act is waiting for the signature of President Bongbong Marcos to become law.

"Itinuturing natin itong isang makasaysayang pagkilala para sa ating lungsod. We are thankful for the support of the Senate, from the deliberations to the approval of our bill," Cong. Lani said.

She added that by formally recognizing the City of Bacoor's contribution to our national history, "We are not only honoring our past but also educating future

generations about the importance of preserving our heritage."

"During my time as mayor of the City of Bacoor, credible references came to light about what had transpired at the Bacoor Assembly in 1898. It was former Prime Minister Cesar E.A. Virata, now chairman of the Cavite Historical Society, who first brought this to our attention," Mercado-Revilla said.

Historical documents indicate that on August 1, 1898, then-President

Emilio Aguinaldo signed the Act of Independence written by Apolinario Mabini.

This was also signed by about 200 elected municipal leaders from 16 liberated provinces, and subscribed to by the Interior Secretary Leandro Ibarra.

According to historians, the earlier declaration made on June 12, 1898, contained the word "protectorate," which would mean that the Philippines would become

a protectorate of the United States of America.

It was for this reason that Aguinaldo did not want to sign this proclamation.

"It is not our objective to diminish the importance of June 12, the anniversary of Philippine independence. We aim for the City of Bacoor to be recognized as part of one of the most important events in the history of our independence," Mercado-Revilla explained.

Under Mercado-

Revilla's mayoral term, the City Tourism Development Office also published the book *Proclamation: Philippine Independence: The Truth About August 1, 1898 Bacoor Assembly, A Historiographical Inquiry*.

The book was authored by Dr. Emmanuel Calairo, president of the Cavite Historical Society.

The House of Representatives approved a similar measure in May 2023.

PhilHealth outpatient program inilunsad sa Quezon

Tayabas City – Inilunsad noong Martes, Setyembre 10 ng Philippine Health Insurance Corporation-Calabarzon (PhilHealth-4A) sa programa nitong Primary Care Provider Network (PCPN) sa 49 rural health units (RHUs) sa lalawigan ng Quezon.

Sa ginanap na "Kapihan sa Bagong Pilipinas" forum sa St. Jude Hotel and Event Center sa lungsod na ito, masayang ibinalita ni Dr. Edwin Oriña, acting regional vice president of PhilHealth, ang programang "Konsultasyong Sulit at Tama," (Konsulta) na layuning maghatid ng mahusay na serbisyong medikal sa pamamagitan ng PCPN.

Nais ng PCPN na maserbisyuhan ang 490,000 tao sa lahat ng 49 RHUs ng probinsiya.

Sa programa, magbibigay ng kumpletong serbisyong medikal ang PCPN sa mga outpatients, ayon sa mandato ng Universal Health Care Law, sabi ni Dr. Orina.

Bukod sa konsultasyon, magbibigay rin sa mga pasyente ng serbisyong health risk screenings, assessments, laboratory at diagnostic tests, at magbibigay ng mga gamot.

Sa serbisyo ng PCPN ang pasyente ay agad-agad na aasikasuhin at hindi na kailangang antayin pang maayong bayarin sa pagpapagamot.

Binanggit din ni Dr. Oriña ang paglikha ng isang a Health Care Provider Network (HCPN) para sa mga pasyenteng gagamutin sa mga publiko at prinadong ospital.

Tiniyak niya na sa HCPN ang pasyente ay tatanggap ng Guaranteed Accessible Medication for Outpatient Treatment.

Itatayo ang HCPN sa Quezon bago matapos ang 2024, at ito ay itatayo rin sa Laguna sa 2025./ Janelle Villanueva, Janeth Bilbao

ligtas nang kainin ang mga lamang-dagat buhat sa Rosario.

Isa si Daisy Narvaez na may-ari ng isang consignment sa fishport ang nakilahok sa sabayang kainan upang ipakita sa lahat ng mamimili na ang kanilang panindang mga isda at alimasag at iba pang lamang-dagat ay ligtas nang kainin.

Layunin sa ginawang sabayang kainan na palakasin ang ugnayang pangkabuhayan ng bawat mamamayan.

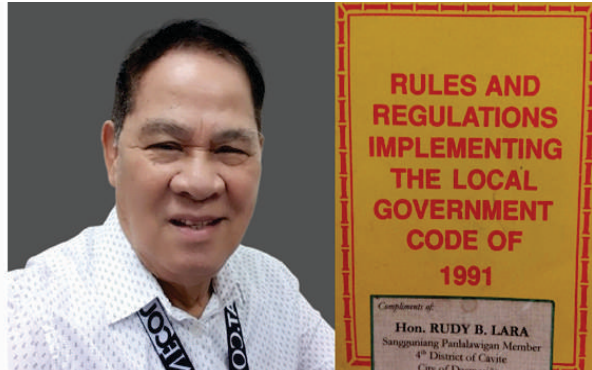

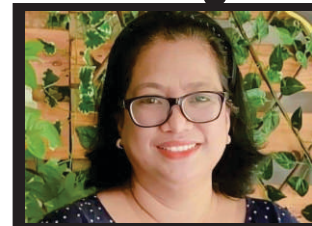

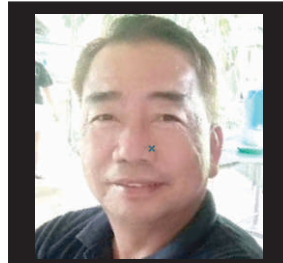
