Embryo Transfer Technology; A new era in goat farming in Cagayan Valley

The goat-raising industry in the Philippines is set to benefit from a groundbreaking technology innovation, as the Department of Science and Technology Region 2 (DOST 2), in collaboration with the Isabela State University (ISU) and DOST-PCAARRD, reported the successful implementation of its Embryo Transfer (ET) Technology for goats.

The development was announced by DOST-PCAARRD Executive Director Dr. Reynaldo V. Ebora during the 2024 Regional Science and Technology Week (RSTW) held in Cagayan Valley.

Dr. Ebora said five kids were successfully produced using the ET technology, which is part of the Innovative Systems in Advancing Technology-Based Goat Production project funded by the DOST-PCAARRD.

Dr. Ricmar P. Aquino, ISU president, emphasized the importance of technological innovations in goat production, and highlighted key technologies such as semen collection, semen processing, and artificial insemination for small ruminants to modernize

House approves Php6.352T budget for 2025

Voting 285 affirmative and three negative votes, the House of Representatives on Wednesday night approved on third and final reading the 2025 General Appropriations Bill (House Bill 10800).

The proposed national budget for 2025 is Php6.352 trillion.

The House also created a small committee to gather the individual amendments of

lawmakers.

It is composed of House Appropriations committee chairperson Elizaldy Co, House Majority Leader Manuel Jose Dalipe, House Minority Leader Marcelino Libanan, and House Appropriations senior Vice chairperson Stella Luz Quimbo.

House members have until Friday to submit their individual amendments to the 2025

national budget..

The House approved the proposal of the Appropriations committee to reduce the budget of the Office of the Vice President to Php 733 million from Php2.037 billion.

The slashed funds would be added to the budget of the Department of Health and the Department of Social Welfare and Development.

The Commission on Elections (Comelec) has issued reminders to the aspirants for public office for the coming May 2025 midterm elections.

Comelec Chairman George Garcia released a graphic reminding those who want to run for public office that they should be Filipino citizens and at least 21 years old.

They should be registered voters in the area they want to run, and must be residents there for at least one year.

They must also be able to read and write.

Garcia said they may file their certificate of candidacy either personally or through a representative.

The filing of certificate of candidacy (COC) period is from October 1 to 8.

The official campaign period is from March 28 to May 10, 2025.

Candidates may only spend P5 per registered voter in the area if they are independent candidates, and P3 per voter if they are part of a political party.

goat production and enhance the efficiency and profitability of goat farming.

Science and Technology Secretary Dr. Renato U. Solidum Jr. said the Embryo Transfer Technology enables the production of multiple offspring from a single female goat, significantly enhancing reproductive efficiency.

The process involves superovulation to maximize the oocyte reserves of a female goat, followed by the transfer of fertilized embryos to recipient

females.

The method increases both the number of offspring and the speed of genetic exchange between herds, thus accelerating the improvement of goat breeds.

Goat meat, or chevon, has been gaining popularity due to its lower calorie, cholesterol, and saturated fat content compared to other meats such as beef, pork, and chicken.

Additionally, the goat industry provides not only nutritious meat and milk but also

supports agricultural diversification and offers a vital source of income for small-scale farmers.

Dr. Cristina Nayga delivered the first embryo transfer (ET) kid in June 2023, with four additional kids produced from three other dams in the following months.

The kids were derived from dams with a 75 percent Boer bloodline mated with purebred Boer bucks.

The experiment marked a significant milestone in ISU's breeding program, which has been looking at enhancing the

DOST trains 14 Jasaan milk producers on food safety



In its mission to enhance its production standards, the United Livestock Raisers Cooperative (ULIRCO) underwent training on Food Safety and Good Manufacturing Practices (GMP) from the Department of Science and Technology—10 (DOST 10).

ULIRCO is a National Dairy Authority-supported group that produces pasteurized milk under the brand name "Fresh Moo" in Jasaan, Misamis Oriental.

Fourteen staff and on-the-job trainees attended the training from DOST 10 on September 10, 2024.

ULIRCO, a recipient of DOST's Small

Enterprise Technology Upgrading Program (SETUP), had previously benefited from milk processing equipment and laboratory analysis services provided through the program in 2022.

The cooperative also received consultancy support through DOST's Manufacturing Productivity Extension Program (MPEX).

The cooperative is obtaining the FDA License to Operate (LTO) and Certificate of

Product Registration (CPR).

ULIRCO's chairman, Wilfredo Perez, expressed his profound gratitude to DOST for their unwavering technical support.

He expressed ULIRCO's eagerness to participate in more DOST programs in the future, recognizing DOST's pivotal role in their journey.

The session was led by Joanah S. Magto, Senior Science Research Specialist of DOST Misamis Oriental, who

addressed the importance of identifying and mitigating food safety hazards, particularly given the perishable nature of milk.
