SA isang survey ng Publicus Asia Inc. na inilabas noong Martes, Okt. 1, korapsiyon ang tinukoy na pangunahing problema na idinadaing ng mamamayang Pilipino.

Ito, ayon sa Publicus, ang sinabi ng 18 porsiyento sa

1,500 respondent sa survey na ginawa mula Setyembre 15-19, 2024.

Bukod sa korapsiyon, idinadaing ng mamamayang Pilipino ang patuloy na pagtaas ng presyo ng pagkain at iba pang

pangunahing pangangailangan at serbisyo na nagrehistro ng 15%, ekonomya, 12% at matinding kahirapan, 11%.

Ang mga ito, ayon sa survey ang kailangang agad na aksyon ni President

Bongbong Marcos.

"Corruption now tops the list, reflecting a growing frustration with governance and accountability across different sectors of society," sabi ng Publicus./BB News Desk

Comelec approves HWP

IN a statement, Health Workers Partylist welcomed the Commission on Elections (Comelec) decision to grant its registration and accreditation as a sectoral organization.

The poll body granted the motion on Sept. 23.

"Our organized efforts have paid off. We have proven once again that organized actions lead us to victory," the HWP said."

PRESIDENT Bongbong Marcos has appointed former executive secretary Oscar Orbos as acting chairperson and member of the Board of Directors of the government's People's Television Network, Inc. (PTNI).

Orbos, who served as executive secretary as well as transportation and communications secretary under the administration of late President Cory Aquino, took his oath yesterday before Executive Secretary Lucas Bersamin, the Presidential Communications Office said.

The new PTNI head

was a former congressman for Pangasinan's first district from 1987 to 1990 and as governor of the province from 1995 to 1998.

Meanwhile, Marcos appointed former PTNI general manager Katherine Chloe de Castro

as director general of the Philippine Information Agency (PIA) and Atty. Francis Carlo Taparan as Director IV of the National Printing Office (NPO).

Taparan was previously head of the Legal Department of the Caloocan City government.



DOST trains 17 Misamis Oriental agri-personnel on product development

THE Department of Science and Technology (DOST), with its Mobile Modular Food Processing Facility (MMFPF), or the Food on the Road Innovation Processing Facility (FoodtrIP), trained 17 personnel from the Provincial

Agriculture Office (PAGRO) of Misamis Oriental on September 13, 2024.

The session, titled "Innovation on Wheels: Product Development using FoodtrIP," was held at the Misamis Oriental Center for Sustainable Development (MOCSID)

in Claveria.

This training aligns with DOST's strategy to ensure regional food security by empowering human resources to produce products from the mobile processing facility.

It also contributes to Sustainable Development Goal

(SDG) 12, which ensures sustainable consumption and production patterns.

Specifically, the training targets SDG 12.3, which seeks to halve global food waste by 2030 by reducing food losses throughout the supply chain, including post-harvest stages.

FoodtrIP is designed to convert surplus agricultural products into value-added goods, minimizing waste and promoting the sustainable use of resources.

In his message, former TESDA Provincial Director Leo V. Velez mentioned that the training would spark community economic activity and entrepreneurial growth, ultimately leading to


