

Jonvic Remulla is Marcos' new DILG secretary

JUANITO Victor 'Jonvic' Remulla, Jr. the younger brother to current justice secretary Jesus Crispin 'Boying Remulla withdrew his reelection as Cavite governor last Monday, Oct. 7 to join in the Marcos Cabinet

Jonvic, long-time governor of Cavite, took his oath as the new head of the Department of the Interior and Local Government (DILG) before Ptesident Bongbong Marcos at Malacanang, at 9 am, Tuesday, October 8.

In a statement, Marcos said Remulla' extensive and excellent work in local government administration made

him his top choice for the DILG post.

"Clearly, Governor Jonvic is more than qualified to handle the challenges of one of the government's most important jobs,"the president said.

On his Facebook page, Jonvic said he accepted the appointment as DILG secretary to help his kababayang Cavitenyo and the entire Filipino people.

Philippines, China trade blame in latest South China Sea spat

BEIJING/MANILA, Oct 8 (Reuters) – The Philippines accused China's coast guard on Tuesday of firing water cannon at government ships taking supplies to fishermen at a disputed shoal in the South China Sea, but Beijing said its "control measures" followed the boats' intrusions in its waters.

The incident was the two countries' latest run-in

regarding the Scarborough shoal, a fishing ground within the Philippines' exclusive economic zone that China claims as its territory.

"We urge the Philippines to immediately cease its violations," Liu Dejun, a spokesperson for China's coast guard, said in a statement.

mas mabuting kinabukasan," Jonvic said.

He said that after 29 years serving in the provincial government of Cavite, 11 and half of which he was governor, "I think I will leave the province much better than when I first came in."

Jonvic replaces Benhur Abalos, Marcos' first DILG chief who is seeking a Senate seat in

2025.

The PCO said that Jonvic's joining the Marcos cabinet would be the first in recent Malacañang history for siblings to be members of the Cabinet at the same time.

The Remulla brothers are sons of bar topnotcher Atty. Juanito 'Johnny' Remulla who, in September 1979 while serving as provincial board member, was appointed governor by President

Ferdinand Marcos Sr. following the death of Cavite Gov. Dominador Camerino.

In the election for governor in January 30, 1980, Johnny was elected, and in 1986, as a Marcos ally, he was one of local government executives forced to resign during the early days of Cory Aquino's administration.

Remulla Sr. served as governor in 1988 until 1995. /ELI TAPARAN II

"invaded the waters" near Scarborough Shoal, it added, prompting what the Chinese side called "control measures".

The Philippine fisheries bureau said its vessels were on a routine mission to resupply fishermen when three Chinese coast guard (CCG) ships and a People's Liberation Army-Navy vessel approached at close distance and shadowed their movement.

The CCG vessels attempted to impede the mission ... but were unsuccessful," it said in a statement. "The CCG vessels also opened and directed their water cannons, but this failed to reach the Philippine civilian boats."

The Philippine vessels were the Datu Cabaylo and the Datu Sunday, it added.

China claims sovereignty over nearly all of the South China Sea, including areas claimed by Brunei, Indonesia, Malaysia, the Philippines, and Vietnam.

JWB: What are the problems the paper encountered, e noong Covid-19, maraming negosyo ang naapektuhan.

DBC: Like any other businesses, the paper was hit hard with loss of advertising and income. But newspapering is not only about money. Newspaper is an essential business that helps inform residents and business leaders about what is happening in our community. BantayBalita and other community papers have a unique role to play. Ito ay maghatid ng balita, impormasyon, mga kaalaman

sa publiko at maging tinig ng mamamayan. To me as a publisher, BB despite the big loss in revenues, we have to be a light, so to speak, in the midst of all the uncertainty.

JWB: Wow! Ano po ang commitment ng BB sa publiko?

DBC: Our paper is committed to informing citizens what's happening in our country. The slate, carrying the vision, "Bagong Bukas Ay Atin", includes eight aspirants for the Sangguniang Bayan.

They are -- Former Barangay Captain Chris Faust; Barangay Captain Pen Gandia; Derick Bote Bautista; Lili Peregrino;

Allan Ilano; Engineer Edgar Repollo; Wee Narvaez and former Sanggunian Bayan member Medel Caimol

"Our slate represents a cross-section of experienced public

servants and fresh voices committed to Kawit's progress," said Abaya.

Abaya said that his team's primary advocacy focuses on two crucial aspects: Healthcare and Housing Program

"Our group is pushing for the implementation of a healthcare card system for every Kawiteño," said Abaya.

He explained that the healthcare card system is similar to Makati City's model.

"Private hospitals typically require P20,000 to P30,000 in down payment. The proposed healthcare card system will provide

immediate access to healthcare services without the burden of upfront payments," BBA said.

The BBA team is advocating for the construction of a housing project within Kawit itself.

The project aims to ensure that residents can remain in their hometown



and prevent forced relocation to other municipalities.

Abaya explained:
