Remulla hails PNP as crime rate drops 62% under Marcos admin

MANILA — The Philippines' crime rate dropped 62 percent during the first two years of the Marcos administration, the Department of the Interior and Local Government (DILG) said Thursday, Oct. 31.

In a statement,

DILG Secretary Jonvic Remulla said the Philippine National Police (PNP) recorded 83,059 incidents from July 1, 2022 to July 28, 2024, way lower compared to 217,830 incidents reported in the same period from 2016 to 2018.

Remulla also cited

the PNP's crime clearance efficiency rate and crime solution efficiency rate, which improved at 27 percent and 10 percent, respectively.

The DILG chief lauded the police force for these achievements, which he said were reached

through hard work and dedication of law enforcement officers across the country.

"These significant feats are a testament to the unrelenting commitment of the PNP to continuously serve and protect the public from criminality and lawlessness,"

Remulla said.

"With this positive development, the DILG urges the PNP to continuously fulfil their sworn duties as vanguards of peace and order towards a safe and peaceful B a g o n g Pilipinas."/Darryl John Esguerra, PNA

DOST Region 02 Expands STARBOOKS Access in Sto. Tomas, Isabela

the importance of monitoring, managing customer profiles, and

'Kristine' damage to irrigation infra in Calabarzon placed at P124-M

CALAMBA CITY, Laguna – The National Irrigation Administration (NIA) 4-A (Calabarzon) said Thursday, Oct. 31, that Severe Tropical Storm Kristine (international name Trami) left about PHP124 million in damage to vital irrigation infrastructure across the region.

This damage is classified as Level 2, indicating that extensive repairs are necessary to fully restore the affected facilities.

Senior engineer of NIA 4-A's Operations Section, Precious Palacol, said in a phone interview that Kristine caused damage to several dams.

Among the major structural damage are the collapse of the counterfort retaining wall downstream of the Sta. Cruz Dam in Liliw, Laguna; damage to the Lateral C canal of the Balayungan River Irrigation System in Naic, Cavite; and the damaged service road and main canal of the Palico River Irrigation System in Nasugbu, Batangas.

The main canal of the Quipot Irrigation Project in Tiaong, Quezon also sustained damage to its canal lining and silt basin at Siphon No. 2.

Palacol said the damage affected 1,298 hectares of farmland and about 1,422 farmers in the region.

Initial crop loss estimates reached

PHP96.6 million, with rice fields primarily affected.

Rice crops in their reproductive and terminal drainage stages, specifically in Laguna were destroyed, with losses valued at PHP20.08 million within National Irrigation Systems.

In Batangas, about PHP35 million in crop losses was recorded within Communal Irrigation Systems.

Palacol said NIA plans to submit a report to the Office of Civil Defense and the National Disaster Risk Reduction and Management Council to secure Quick Response Fund assistance.

Since last week, NIA field teams, along with local irrigators associations, have begun urgent desilting and clearing operations along irrigation canals to remove debris and restore regular water flow, she said.

"The agency is continuously evaluating the condition of various dams and irrigation facilities in the region, especially in Quezon province, in light of possible impacts from Typhoon Leon," Palacol said.

"NIA remains committed to restoring critical irrigation infrastructure to mitigate further agricultural and economic impacts on Calabarzon's farming communities," she said. / Zen Trinidad, Philippine News Agency

Human rights petitions vs Duterte reaches finality

MANILA, Philippines — The dismissal of petitions for protective writs filed by several human rights groups where former President Rodrigo Duterte was impleaded has attained finality.

In a document made public Thursday, the Supreme Court has already released the entry of judgment for the case of which a decision has become final and executory on April 29, 2024.

Under court rules, an entry of judgment means the decision was already recorded in the SC's Books and can no longer be appealed or revised.

The case was about the petition for

The said petition was dismissed by the 14th Division of the Court of Appeals on June 28, 2018.

The petition for review on certiorari, filed on June 28, 2019 at the Supreme Court which raised issues on the CA decision, was followed by two more manifestations filed by KARAPATAN, after the extrajudicial killing of three of its human rights workers—Zara Alvarez, Ryan Hubilla and Nelly Bagasala— who were supposed to testify in the hearings.

Karapatan expressed dismay over the SC decision.

Imee seeks full disclosure of P132-B Bicol flood control budget

MANILA - Senator Imee Marcos said Wednesday, Oct. 30, the public deserves transparency on what happened to the PHP132 billion allocated since 2018 for flood control in Bicol after continued severe flooding in the region.

"It is unacceptable that PHP132 billion has been designated for Bicol flood control projects, yet communities remain inundated, and families are suffering. The public deserves transparency on where these funds went," Marcos said in a news release.

Based on the 2024 General Appropriations Act, Bicol received PHP31.94 billion this year alone, bringing the six-year total to nearly PHP133 billion.

Of this amount, Marcos said more than PHP86.6 billion was allocated in just the past two years.

She said flooding brought by Severe Tropical Storm Kristine (international name Trami) has once again exposed inadequate infrastructure and critical gaps in flood mitigation.



Marcos asked the Department of Public Works and Highways (DPWH) to provide a full accounting of the funds and progress of these projects, adding that she would support a thorough investigation into the budget's use, set for discussion in the November budget hearings.

"For the 2025 budget, we need concrete, well-engineered solutions that effectively address climate threats, not outdated projects that risk lives, homes, and livelihoods," she said. /Leonel Abasola, PNA
