Together with former ABS-CBN reporter Nina Corpuz, Tulfo will co-anchor "Arangkada Balita" -- a one-hour newscast that will air from Monday to Friday at 5:30 p.m. starting January 6 on 31.1, PRTV Prime Media's digital free television channel.

Tulfo concurrently hosts public service programs on PYV and the state-run Radyo Pilipinas radio station.

Tulfo is running for senator in the 2025 elections under the Marcos administration-backed Alyansa para sa Bagong Pilipinas.



## Boga, Kwitis at iba pang paputok, sanhi ng maraming nasaktan sa pagsalubong sa 2025

Umabot sa 534 ang kabuuang bilang ng Firework Related Injuries (FWRI) mula Disyembre 22, 2024 hanggang alas-6 ng umaga ng Enero 2, 2025.

Ayon sa ulat ng PNP Region 4-A, mas mababa ito ng 9.8% kumpara sa 592 kasong naitala noong 2024.

Sa report, sinabing ang kwitis at boga ang pangunahing sanhi ng

FWRI na naitala sa 62 sentinel sites na binabantayan ng DOH.

Siyamnapu (90) sa kabuuang kaso ang nasabugan ng Kwitis habang 79 ang kaso ng nasabugan ng Boga.

Marami sa biktima ay nasa edad 19 anyos pababa na a umabot 322 kaso.

Dagdag pa rito, 254 na kaso ay mga aktibong gumamit ng paputok.

Sa pag-iikot naman ng DOH noong Huwebes, Enero 2 sa mga ospital, ipinakita sa tala ng Philippine General Hospital (PGH) nagkaroon ito ng tatlóng (3) kaso ng amputations o pagputol sa bahagi ng katawan mula sa kabuuang 17 kaso ng FWRI na naitala ng ospital mula Disyembre 21, 2024 hanggang Enero 2, 2025.

Inikutan din ng Kagawaran ang Tondo Medical Center na nakapagtala ng 56 Ba kaso ng FWRI mula Disyembre 21, 2024 hanggang Enero 2, 2025.

Sa naturang bilang, 29 ang nagpaputok habang nakainom ng alak, at isang tao ang isinailalim sa

amputation.

Matapos naman ang sunud sunod na handaan, binabantayan pa rin ng DOH ang mga kaso ng non-communicable diseases (NCDs) tulad ng acute stroke, acute coronary syndrome (ACS), at bronchial asthma mula sa walong sentinel sites sa bansa.

Sa pagbabantay ng DOH, lumabas na tumataas ang bilang ng mga stroke patients sa pagsalubong ng bagong taon.

Mula sa 12 na naitalang kaso ng stroke noong Disyembre 23, umakyat ito sa 146 na pasyente noong Enero 2, 2025.

Dalawa sa nasabing bilang ang namatay.

Naitala ang pinakamataas na bilang ng stroke patients na nasa 45 hanggang 64 years old. Nakapagtala naman ng 140 stroke cases ang PGH, habang 41 sa Tondo Medical Center.

Mula naman sa 2 kaso ng acute coronary syndrome (ACS) noong Disyembre 22, umakyat na sa 74 ang ACS patients na naitala ng ahensya mula sa sentinel sites hanggang Enero 2, 2025.

Isa (1) naman sa nasabing bilang ang namatay.

Nasa 55 anyos hanggang 74 ang mga pasyenteng tinamaan ng ACS.

Nakapagtala naman ng 63 kaso ang PGH, habang walo sa Tondo Medical Center.

Ang ACS ay ilang kondisyon na nauugnay sa biglaang pagbabago sa daloy ng dugo sa puso. at kasama sa mga kundisyong ito ang myocardial infarction o atake sa puso.

Kasalukuyang binabantayan ng DOH ang kaso ng bronchial asthma dahil sa usok mula sa mga paputok.

Mula 6 na kaso noong Disyembre 22, umakyat sa sa 80 ang inatake ng matinding hika noong Enero 2 at mga sanggol ar bata na 9 na taon ang naging biktima ng matinding usok ng paputok

Apatnapu't anim (46) ang naitalang bronchial asthma cases ng PGH, habang 11 sa Tondo Medical Center.

## CJ Gesmundo describes 2024: Year of growth, transformation for judiciary

In his New Year's message on Tuesday, Dec. 31, Chief Justice Alexander Gesmundo said that "year 2024 has been a period of profound growth and transformation."


Gesmundo said that the reforms in the judiciary "have not only been about strengthening the very foundations of justice—ensuring that our judicial system serves the people with fairness, efficiency, and integrity; providing equal access to all, regardless of background or circumstances; and leveraging technology to equip the judiciary in meeting the demands of a rapidly-evolving



world."

He admitted that during the implementation of reforms "we faced difficulties."

The chief magistrate urged the judiciary to "continue to embrace the ongoing reforms with the same dedication and determination that have defined our journey thus far."

# Researchers eye more partners to test hand-writing tool research

Local researchers have developed a handwriting assessment tool, are looking to get more partners to conduct more tests across the country.

The Intelligent Stroke Utilization, Learning, Assessment, and Testing (iSULAT) is an intelligent pen that provides a practical solution for assessing children's handwriting to provide objective evaluation based on the most common handwriting tools, such as tests of Visual-motor skills, Minnesota handwriting assessment, and an evaluation tool for children's handwriting.

The iSULAT has a microcontroller within the pen, which transmits data to a mobile application.

The raw signal undergoes filtering, feature scaling, engineering data, and analyses before it is forwarded to the occupational therapist for diagnosis.

Through the pen, the occupational therapist can efficiently assess

one's handwriting based on the alignment of letters, spacing, and consistency.

A separate report mentioned that the number of handwriting problems in developing children reached an approximate 5 to 25 percent range.

Handwriting is still the most immediate form of graphic communication and failure to attain proficiency during the school-age year may result in far-reaching negative effects on both the academic success and self-esteem of a child.

This project was funded by the Department of Science and Technology-Philippine Council for Health Research and Development (DOST-PCHRD), with a budget of PHP3.2 million for its initial phase.

"Yung mga ganitong invention, kailangan niyan ng testing. Hindi lang isa. Dapat tine-test siya ng mas marami para mas ma-check kung accurate or kung maganda na yung pine-performing prototype," said



Engr. Jomel Herras, Project Manager of iSULAT.

Engr. Herras added that his team is looking for more enthusiasts and partners who will help them promote iSULAT to gain more users from various locations.

The iSULAT is one of the technologies featured in the recently concluded 2024 National Science and Technology Week, held in Cagayan de Oro City from 26 November to 01 December 2024.

"Basically ina-address na problem ni iSULAT is yung kakulangan natin ng occupational

therapists at mahal na cost ng therapy," said Engr. Herras.

"Siguro yung pinaka rootproblem ay yung problema ng mga bata sa kanilang handwriting. They do it in their everyday lives. Nagsusulat sila even in Math, Arts, and English subjects. Yung ibang mga bata, hindi sila enthusiastic kaya akala natin tamad lang sila magsulat," Herras added.

With the help of iSULAT, children with handwriting problems can undergo simultaneous testing in batches or groups.

During phase I, the project team conducted pilot

testing for children ages 6-10 in three sites across Luzon namely Villa Maria Elementary School in Porac, Pampanga; Juan Sumulong Elementary School in Metro Manila; and Bulacan Montessori School Inc. in Bulacan.

Herras said that phase I of the project started in 2022 and ended last 31 October 2024.

"Hopefully by 2026 ay mayroon nang phase II na kung saan ay maiaapply na natin ito hindi lang para sa mga bata," Herras explained. He added that the project targets those with Attention Deficit

Hyperactivity Disorder or ADHD and autism.

The project team has secured a partnership with the Department of Education (DepEd) Division of Metro Manila for future testing.

### HMO allowance to civilian gov't workers

Starting this year, civilian government workers will be receiving a medical allowance for a health maintenance organization or HMO's services of up to P7,000 per annum.

The Department of Budget and Management (DBM) said Thursday, January 2, that the allowance applies to all types of those employees working on a regular, casual, contractual, appointive or elective, full-time, or part-time basis.

"This is a promise fulfilled. This medical allowance is not just a benefit, it's a vital investment in safeguarding a healthy workforce and ensuring that they perform at their best," DBM Secretary Amenah Pangandaman said.

The beneficiaries can receive the medical allowance in the form of HMO coverage either through their government agencies or employee organizations.

Those who will avail of their own HMO providers or have already paid for medical services can receive the allowance in cash.

## PhilHealth boosts benefit packages for heart diseases

The Philippine Health Insurance Corp. (PhilHealth) maximize the coverage of its benefit packages for heart diseases by as much as 1,629%.

PhilHealth announced the enhanced benefit packages on Thursday, January 2, as detailed in Circular 2024-0032 issued on Dec. 21, 2024.

For inpatient admissions, Filipinos with ischemic heart disease — a condition caused by reduced blood flow to the heart — and acute myocardial infarction, or heart attacks, can now avail of increased coverage

under two enhanced benefit packages.

The reimbursement rate for percutaneous coronary intervention, a non-surgical procedure to clear blocked arteries and remove plaque buildup, has been raised to P523,853 — about 17 times higher than the previous coverage of P30,300.

Patients may avail of this procedure at any of the 70 accredited cath labs in the country.

The second enhanced package covers fibrinolysis, a treatment for dissolving blood clots. It now has a case rate of P133,500, or a 341% increase from

the previous amount of P30,290.

The state insurer also increased the benefit package for emergency medical services with coordinated referral and interfacility transfers to P21,900 and cardiac rehabilitation to P66,140.

The total value of the benefit packages covers both the payment to the healthcare institution and the fees for healthcare professionals.

The benefit packages also cover services such as emergency care, medications, laboratory tests, medical supplies,

equipment, and other administrative fees.

They will apply to accredited public and private health facilities classified as Levels 1 to 3, equipped to provide the necessary medical treatments and procedures. The levels correspond to the range of services each hospital can offer.
