#### PROVINCIAL ORDINANCE NO. 484-2025

AN ORDINANCE ESTABLISHING PROVINCIAL STANDARDS AND GUIDELINES FOR THE INSTALLATION AND MAINTENANCE OF ROAD AND SAFETY SIGNAGES IN SCHOOL ZONES WITHIN THE PROVINCE OF CAVITE, IN COORDINATION WITHALL CITIES AND MUNICIPALITIES

Introduced and sponsored by: Hon. Francisco Gabriel D. Remulla Chair, Committee on Education Sponsored by: Hon. Ramon Vicente H. Bautista Chair, Committee on Peace, Public Safety and Order and

Co-sponsored by: All Sangguniang Panlalawigan Members

WHEREAS, Section 16 of the Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides in part that every local government unit shall exercise the powers expressly granted, those NOW, THEREFORE, on motion of Hon. Remulla and Hon. Ambion, duly necessarily implied therefrom, as well as maintain peace and order, and seconded by Hon. Sison and unanimously approved by the Members preserve the comfort and convenience of their inhabitants.

WHEREAS, Section 468 (a)(1) of the same Act, grants the Sangguniang Panlalawigan authority to enact ordinances necessary for efficient and effective provincial governance;

WHEREAS, Republic Act No. 4136, otherwise known as the Land Transportation and Traffic Code, provides traffic regulations, including the need for road signage in designated zones, such as school zones;

WHEREAS, the safety of students, teachers, school personnel and visitors

in school zones is critically important;

WHEREAS, proper road signages can help prevent accidents and promote safer environment in school zones throughout the province;

WHEREAS, there is a need to enhance the visibility of road safety measures and establish emergency preparedness n school zones across the Province of Cavite through collaborative action with local governments;

present, be it enacted by the Sangguniang Panlalawigan of Cavite in a session duly assembled that:

Section 1. Short Title. This ordinance shall be known and cited as the "Cavite School Zone Road and Safety Signages Standards Ordinance."

Section 2. Purpose. The purpose of this Ordinance is to establish standardized provincial guidelines for road and safety signages in school zones, promoting enhanced safety and emergency preparedness in collaboration with all cities and municipalities within the Province of Cavite.

.Section 3. Coverage. This Ordinance applies to all cities and municipalities within the Province of Cavite and serves as a framework for regulating road and safety signages in school zones at all public and private educational institutions, including, but not limited to, elementary, secondary, and tertiary institutions in the Province of Cavite.

Section 4. Definition of Terms. As used in this Ordinance, the following terms shall be defined as follows:

- a. School Zone refers to an area extending from 100 meters before the entrance to a school and 100 meters beyond the exit, designated for special safety measures.
- b. Road and Safety Signages Include but are not limited to traffic signs, pedestrian crossings, speed limits, warning signs, and emergency information boards in school zones.
- Section 5. Provincial Standards for Road and Safety Signages. In collaboration with cities and municipalities, the following standards shall be adopted as a guideline for school zones in Cavite:
- a. Speed Limit Signs: Clear signs displaying a maximum speed limit of 20 km/h within school zones.
- b. Pedestrian Crossing Signs: Marked pedestrian lanes and signs alerting the motorists.
- c. School Zone Warning Signs: Visible signs indicating the presence of a school zone, with flashing lights during school hours if possible.
- d. Emergency Preparedness Information: Signboards displaying evacuation routes and emergency contact numbers, placed in strategic locations.

All road and safety signages installed pursuant to this Ordinance shall conform to the latest standards prescribed by the DPWH Road Safety Design Manual, the DOTr-DPWH-DILG Joint Memorandum Circulars, and relevant issuances of the LTO.

Section 6. Implementation and Local Adoption. All cities and municipalities are encouraged to adopt these standards through local ordinances tailored to meet specific conditions within their jurisdictions, ensuring alignment with provincial objectives for school zone safety.

Section 7. Responsibilities for Maintenance of Signages. Educational institutions shall be responsible for the maintenance and visibility of safety signages within their internal premises. Road and safety signages located along public roads and right-of-way areas shall be under the jurisdiction of the respective city or municipal government in coordination with the Provincial Government.

Section 8. Formulation of the Implementing Rules and Regulations. The Office of the Provincial Governor-Road Safety Division (OPG-RSD) and Provincial Government – Cavite Office of Public Safety (PG-COPS) in collaboration with the Committee on Education and the Committee on Peace, Public Safety and Order of the Sangguniang Panlalawigan shall formulate the IRR of this Ordinance within sixty (60) days upon its approval. The formulation process should involve consultation with representatives from cities and municipalities within Cavite to ensure the IRR aligns with local capabilities and needs.

In the event that the Implementing Rules and Regulations (IRR) are not promulgated within sixty (60) days from approval, the minimum safety standards under Section 5 shall be deemed immediately executory and enforceable.

Section 9. Monitoring and Evaluation. The Office of the Provincial Governor-Road Safety Division (OPG-RSD) and Provincial Government — Cavite Office of Public Safety (PG-COPS), shall oversee and coordinate the implementation of this Ordinance in all cities and municipalities within the Province of Cavite.

1.Inspections and Compliance Monitoring: The OPG-RSD, with support from PG-COPS, shall conduct regular inspections of school zones to ensure compliance with the road and safety signage requirements set forth in this

Ordinance. Inspections shall be conducted at least two (2) weeks before the start of the school year and after each semester.

- 2.Reporting and Evaluation: Each LGU shall submit a compliance report to the OPG-RSD. The OPG-RSD and PG-COPS will review these reports to monitor compliance, address any safety concerns, and recommend improvements to the Sangguniang Panlalawigan if needed.
- 3.Ongoing Coordination: The OPG-RSD will maintain communication with LGUs, providing guidance and public safety expertise from PG-COPS to support uniform implementation and compliance across the province.

#### Section 10. Penalties.

Any entity or individual found responsible for willfully damaging or tampering with road and safety signages shall be subject to a fine of Five Thousand Pesos (Php5,000.00) or imprisonment of up to six (6) months, or both, at the discretion of the court.

Any educational institution or local government unit found to have failed to comply with the provisions of this Ordinance within sixty (60) days from notice shall be subject to administrative sanctions, including, but not limited to the suspension of provincial support funding or issuance of notices of violation, without prejudice to the filing of appropriate charges under applicable laws.

Section 11. Funding. The implementation of this Ordinance shall be funded through the annual budgets of the educational institutions and the Provincial Government of Cavite. Cities and municipalities are encouraged to allocate funds for the implementation and enforcement of this Ordinance within their respective school zones.

Section 12. Repealing Clause. All previous ordinances, resolutions, executive issuances or rules and regulations or parts thereof, whose provisions are inconsistent with or contrary to the provisions of this Ordinance, are hereby deemed repealed, amended or modified accordingly.

Section 13. Applicability Clause. All existing ordinances, resolutions, and executive issuances not inconsistent with this Ordinance shall be deemed supplementary and shall continue to be effective. In cases of conflict, this Ordinance shall prevail.

Section 14. Separability Clause. If, for any reason, any section/s or provision/s of this Ordinance is/are held unconstitutional or invalid, the section/s or provision/s not affected thereby shall remain in full force and effect.

Section 15. Effectivity. This Ordinance shall take effect after its approval and compliance with the posting and publication requirements.



# **BPIS Irrigation System Sustains Cavite Farmlands Century-Long**

THE longest subterranean irrigation system in the nation, the Bancod-Palauit Irrigation System (BPIS), has been providing water to Cavite farmlands for over a century.

To maintain irrigation even during dry months, the system starts at the Bancod Dam in Indang, where water from springs and streams is collected before travelling through a labyrinth of canals and tunnels.

Water is discharged into smaller canals that supply rice fields in General Trias and Rosario via BPIS, which stretches to Palauit in Trece Martires City.

In addition to being an agricultural lifeline, engineers and local historians view BPIS as a tribute to the inventiveness of past generations who created the system without the use of contemporary machinery.

The network is still a part of Cavite's cultural identity and helped ensure food production in the province.

One of Cavite's most enduring engineering landmarks, the BPIS demonstrates how early technology, community skills, and natural resources may be combined to support rural livelihoods.

Authorities actively preserve and enhance the BPIS, recognizing its significance for agriculture and local heritage.

As communities work together to maintain this historic system, they are fostering a deeper appreciation for traditional practices while adapting to modern challenges.

This collaborative approach strengthens community ties and promotes sustainable practices that benefit future generations.

was my first experience to work with the nominee. As an enumerator, he was responsible, industrious, and worked happily with others. As such, after the survey was finished, when the dean asked my opinion on who among the enu-

merators have the potentials to be employed, the nominee was included in the list of the names that I have suggested.

"Endowed with these good personal qualities, characteristics, and other abilities, the nominee was hired to teach at the high school department of DSAC. Being a small academic community at that time, everybody had a close interaction with each other, even those as-

signed at the different offices, units or departments. While I was working at the Planning and Development Office, under the direct supervision of the college dean and he was at the secondary school, I recall how the nominee pursued his intention to improve his and his family's situation. First, for their living conditions, through government and personal loans, he was able to buy a

piece of land and built new house, few meters away at the back of our place.
