CvSU is a public university in the province of Cavite in the Philippines. Its 70-hectare main campus, known as the Don Severino delas Alas Campus,

is located in the Municipality of Indang, Cavite about 60 km southwest of Manila. The educational institution has twelve other campuses spread all over the province.

The school was established initially as an intermediate school by the Thomasites, a group of American teachers brought by the United States during the early part of the American colonial period to revamp the system of education in the country. By 1964, the school has grown into a college known as the Don Severino Agricultural College (DSAC). It became a university on January 22, 1998, and was renamed as the Cavite State University.



The National Grid Corporation of the Philippines (NGCP) continues to improve its grid response capabilities in case of large-scale power outages or system disturbances with the conduct of its annual Blackout Drills.

Conducted separately for the Luzon, Visayas, and Mindanao grids, the NGCPled Blackout Drills aligns the contingency response of every player in the energy sector, particularly the generation plants.

With the theme "Blackout Readiness: Strengthening Response Capabilities," the Annual Blackout Drill included both tabletop discussions and practical simulation exercises.

"Through these drills, NGCP can evaluate communication protocols, assess response times, and strengthen coordination efforts. We are able to identify weaknesses, if any, and address them proactively, in coordination with our partner stakeholders," NGCP said.

The table-top presentations include discussions on black start services, actual restoration experiences, blackout restoration guidelines and procedures, breakout sessions, and workshops focusing on area-specific blackout restoration highways.

A simulation drill is held a week after the tabletop presentation to replicate an actual blackout scenario.

The activity was attended by stakeholders from the generation sector and distribution sector, as well as representatives from the Department of Energy (DOE) and Energy Regulatory Commission (ERC), Power Sector Assets and Liabilities Management Corporation (PSALM), National Power Corporation (NPC), National Transmission Corporation (TransCo), Wholesale Electricity Spot Market (WESM), Philippine Electricity Market Corporation (PEMC), Independent Electricity Market Operator of the Philippines (IEMOP), Philippine **Independent Power Producers Association** Inc. (PIPPA), and National Electrification Administration (NEA).

One of NGCP's main functions as the country's transmission operator is to constantly enhance operational efficiency of power transmission network operations, particularly that of System Operations. ###

Lessons learned in this article are applicable at home, in school, and at the workplace.

Dr. Zimmerman started his tips with a question: "Have you ever noticed people who have got a title without any corresponding talent?"

seen the so-called leaders - team leaders, supervisors, managers, directors, and vice presidents – at work, who often know little about leading others. And you have seen people in your neighborhood who are called parents, but they seldom 'parent' their kids."

He added that "By contrast, the most effective leaders combine the title and their talent. In particular, they use strategies that bring out the best in others.'

These strategies include: 1) Exhibit a strong belief in the people you are leading, 2) Show your understanding of the people you are leading, and 3) Pass the 5-point leadership quiz every day.

Exhibit a strong belief in the people you are leading (Zimmerman)

For the most part, the people around you know how you feel about them and what you expect No, you would show a patient understanding of them and write them down. from them. And to a great extent they will live up or down to your expectations.

So ask yourself: What do you expect of other people? Do you expect them to perform well? Or do you expect them to goof up, slide by, and slack off without your constant supervision?

Some leaders really struggle with this simple understanding. concept of positive expectations and believing in In his book called Inter-being, Thich adds that, others. Highly effective leaders know that everyone on their team has a vast reservoir of untapped potential. And using the right approach, these leaders help their people release and use their untapped potential.

So what is the right approach? It starts with understanding.

Show your understanding of the people you are leading (Zimmerman)

"Never discourage anyone who continually makes progress, no matter how small," says Plato.
