Romualdez not filing cases vs. accusers in flood control mess 'for now'

Speaker and Leyte Rep. Martin Romualdez won't file complaints against individuals accusing him of being involved in the flood control project mess for now, according to Surigao del Norte Rep. Ace Barbers.

"I don't think that [filing charges] is being considered right now, although we respect the other members of the House who said they will file charges against the Discaya couple who linked them to the flood control mess without presenting evidence," Barbers, Romualdez's chief communications officer, said in a Balitanghali interview on Friday.

The Discaya couple own St. Gerrard Construction firm, which is in the middle of alleged multi-billion ghost flood control projects being investigated at the Senate and the House of Representatives.

Barbers noted that while Romualdez is being linked to the anomalous flood control projects, Curlee Discaya himself said that he did not personally transact with the Speaker.

"Up to now, the allegations are hearsay. Mr. Discaya himself said he did not have a direct transaction with the Speaker," Barbers pointed out.

Barbers also earlier denied Dasmariñas Rep. Francisco "Kiko" Barzaga's insinuations that Romualdez is involved in implementing flood control projects in Dasmariñas when Romualdez served as the caretaker of the district in light of the death of Kiko's father, then Dasmarinas Rep. Elpidio Barzaga.

Barbers called on Barzaga to back up his allegations.

"We appeal to him to show evidence, and he is free to seek an audience with the Speaker to resolve issues he might have been harboring," Barbers added.

Barbers also dismissed the call of

Navotas Rep. Toby Tiangco for a supposed "overhaul" in the House leadership.

"Rep. Tiangco's statements are nothing more than the voice of frustration. Neither he nor Rep. Albee Benitez [of Bacolod City] was even nominated for Speaker. Not a single member of the House cast a vote in their favor. That reality speaks louder than today's rhetoric," Barbers said.

"All party leaders remain firmly committed to the supermajority coalition under the leadership of Speaker Romualdez. Allegations raised against him and other lawmakers regarding flood control projects are baseless, without evidence, and sourced from polluted origins. The Speaker has categorically denied these accusations and has repeatedly stated that anyone proven guilty of wrongdoing will never be shielded by his leadership," emphasized Barbers

DOJ thumbs down state witness status for Discayas

The Department of Justice (DOJ) on Friday said it is not inclined to admit couple Pacifico "Curlee" and Cezarah Rowena "Sarah" Discaya as state witnesses in the ongoing investigation into ghost flood control projects.

"Given what we know there should be restitution. Kaya sinabi ko kay Senate President (Vicente Sotto III), kung ako, ayoko na ibigay yung status (as state witness), kasi hindi forthcoming (That's why I told Senate President, for me, I won't give the status as state witness, because they are not forthcoming)," Jus-

tice Secretary Jesus Crispin Remulla said in an interview with reporters.

"You have to tell the whole truth, di pwedeng mamili. Dapat sabihin nya yung buong kasaysayan (They cannot choose what to divulge. They should tell the whole story)," he added.

He added that the government will also screen the qualification of other persons, such as the engineers involved in the controversy, to turn government witnesses.

"We will evaluate (them). We have several laws that govern state witnesses" he said.

The Procurement Service-Department of Budget and Management (PS-DBM) earlier cancelled the Philippine Government Electronic Procurement System (Phil-GEPS) membership of nine companies associated with the Discayas.

The PS-DBM is also preparing to remove more firms -- including SYMS Construction Trading and Wawao Builder -- from the registry, once the Department of Public Works and Highways (DPWH) issues official blacklisting orders.

The move is in line with the New Govern-

Senator hails realignment of flood control funds to education, health

Senate Minority Leader Alan Peter Cayetano on Friday hailed President Ferdinand R. Marcos Jr.'s announcement that PHP225 billion in funds originally allotted for locally funded flood control projects in the proposed 2026 budget will instead be redirected to education, health, and other pressing needs.

"It's high time that we make the hard decisions and put our money where our mouth is. We have to be radical with the 2026 national budget," Cayetano said in a statement.

Cayetano had repeatedly called for radical budgetary decision, including addressing the 165,000 classroom shortage

through the public works budget.

He said that for the last two years, the Department of Public Works and Highways (DPWH) has a budget of more or less PHP1 trillion pesos. "PHP350 billion of that goes to the flood control projects, and this amount can be used by state universities and colleges," he said.



Infrastructure President Ferdinand "Bongbong" Marcos Jr. issued Executive Order No. 94 creating the ICI that will investigate and undertake appropriate measures against those involved in irregularities in government infrastructure projects.

The independent body has the authority to issue subpoenas for attendance of witnesses and production of documents necessary for its fact-finding and investigation activities, specifically, subpoena ad testificandum and duces tecum in accordance with relevant laws, rules and regulations.

It can also recommend to the Department of Justice (DOJ) the admission of a person as a state witness, in cases where there is a need to utilize a person as a state witness, to ensure that the ends of justice be fully served, provided such person qualifies as a state witness under the Rules of Court of the Philippines.
