# 3 HVIs arrested in a buy-bust operation in Dasmarinas

SUSPECTED shabu items worth P1.7 million were confisctaed by police operatives from Dasmarinas City during a successful buy-bust operation, Wednesday, Sept. 17, the Cavite Provincial

Police Office (CPPO)

Cavite provincial police director, Colonel Ariel said that three high-value individuals (HVIs) were arrested and identified through their aliases as "Owen," "Sop," and "Jen," all residents of Dasmariñas City.

The raid was conducted in Barangay Datu Esmael where the police seized two knot-tied plastic ice bags and two heatsealed sachets containing around 250 grams of suspected shabu.

The buy-bust money was also recovered from the suspects who are now undergoing tactical interrogation.

In a statement re-



leased to media, Col. Red emphasized the commitment of the

Cavite police "to shield communities from the grip of illegal

drugs,."

Red added that every successful operation strengthens efforts toward safer streets and a drug-free province.

The suspects have been charged before the prosecutor.s office for violating Republic Act 9165, or the Comprehensive Dangerous Drugs Act of 2002. / Janeth W.



# May kulong ba kung mabigong magbayad ng inutang?

AYON sa Article III, Section 20 of the 1987 Philippine Constitution ay maliwanag na inihahayag: ""[n]o person shall be imprisoned for debt or nonpayment of a poll tax.'

Ibig sabihin, walang sinoman ang maipabibilanggo sa hindi pagbabayad ng utang o ng poll tax.

Ang pagtiyak na hindi maibibilanggo ang isang tao dahil sa kabiguang makapagbayad ng utang ay malinaw na naipahayag sa kasong George H. Ganaways vs, J.W. Quillen, GR 18619, Feb, 20, 1922., Ponente: US Supreme

Court Associate Justice George Malcolm.

Pero may mga kaso ng pag-utang na maaaring usigin o kasuhan ang isang mayutan, ito ay kung ang pag-utang ay may kalakip na panlilinlang, halimbawa, estafa na may parusang pagkakulong.

Ano ang maaaring gawin ng isang may pautang upang maibalik ang salaping naipautang (creditor)?




