**MARAMING** salamat po, Ama, naririto ako, patuloy sa masiglang pagpupuri sa Iyong kabutihang, at patuloy na pangangalaga sa aking kalusugan, sa aking pamilya at mga minamahal sa buhay.

Today, I am living my life with simple joys – ang aking maybahay, mga anak, mga apo at mga katropa sa munting hanapbuhay at ang pagiging munting publisher at patuloy pa ring pagsusumikap na maging mahusay na journalist

Today, I am celebrating my \_\_ birthday, (sorry, batambata pa) and after my morning prayers, I opened the window inside my little room, and the morning light greets me, whisper to me, "Brother Domz, happy celebrations to you."

Yes, I never imagined that life would test him so deeply.

Kailan ba iyon nang madiagnosed ako na may sakit sa puso?

# Misnomer about Christmas

**WHAT is this phenomenon called Christmas? Is it a Christian or a pagan practice?**

According to New Lexicon Webster's Encyclopedic Dictionary of the English Language (1992), Christmas is defined as the annual festival observed by Christians on December 25, commemorating the birth of Christ.

At this juncture, the date has been mentioned – December 25. As far as history is concerned, the birthplace of our Lord Jesus Christ was at Bethlehem in Israel.

If we are going to analyze the situation based on reality and eventuality, it could not

follows: Why is Christmas not celebrated in the Church Of Christ?

The foregoing is the vivid response to the query and I quote:

“Not only are the word ‘Christmas’ and its observance not found in the Bible – its celebration is also riddled with pagan ways and practices, so we do not take part in it.

The Lord God strictly forbids His servants from adding anything in His commands (Deut. 12:32, New International Reader's Version) – warning of grave punishment to anyone who will

up living as pagans do with their futile notions.

Their minds are closed, they are alienated from the life that is in God...’ (Eph. 4:17-18, Revised English Bible).

The popular belief that Christ was born on December 25 has no basis in fact. The Holy Scriptures does not specify the date of Lord's birth. Walter Woodburn Hyde, a professor of Latin, Greek, and ancient history, testifies:

‘The most widespread myth in Christendom is that of Christmas. Those who take the Bethlehem birth-story as history readily accept the traditional date of Christ's birthday. But all branches of the Church agree that no data exist for determining the day, month or year of the event nor was such a festival celebrated in Apostolic or early post-Apostolic times’ (Paganism to Christianity in the Roman Empire, p. 249).

Regarding December 25 as the alleged birthdate of Christ, a Jesuit priest, Francis X. Weiser, wrote: ‘...the choice of December 25 was influenced by the fact that the

**Modern simulated birthing place of the Lord Jesus Christ – a barn, but is it true...?**

Romans, from the time of Emperor Aurelian (295) had celebrated the feast of the sun god (Sol Invictus: the Unconquered Sun) on that day. December 25 was called the ‘Birth-day of the Sun,’ and great pagan religious celebrations of the Mithras cult were held all through the empire...’ (Handbook of Christian Feasts and Customs, p. 61). Likewise, the customs and traditions observed during the Christmas season are pagan in origins. John F. Sullivan, a Catholic prelate explains:

‘When we give or receive Christmas gifts, and hang green wreaths in our homes and churches, how many of us know that we are probably observing pa-

gan customs? We do not wish to assert that they are good customs; but they undoubtedly prevailed long before Christian times. The Romans gave presents on the New Year's Day, and our bestowing of gifts at Christmas is a survival of that practice...’ (The External of the Catholic Church, p. 208).

Did the true Christians of the first century celebrate Christmas? Sullivan explains further: ‘...There is no mention in any of the oldest list of Church festivals...’ (Ibid, p. 204).

Just because we do not participate in the celebration of Christmas doesn't mean we ignore our Lord Jesus Christ.

On the contrary, by refusing to take

part in the pagan practices attached to such observance, we honor our Lord Jesus Christ because we follow God's commands – no more, no less.”

Hence, the December 25 dictum as the birthdate of our Lord Jesus Christ is a misnomer and has been proven unchristian. It is a pagan practice – devoid of God's teachings.
