embahada, sinabi ni Ji Lingpeng hindi na kailangang palalimin pa ang isyu.

"I think there is no need to go through such trouble. They could simply declare Ambassador Jing Quan 'persona non grata' – that would be the most straightforward approach."

("Sa tingin ko, hindi na kailangang dumaan pa sa ganitong kaha-bang proseso. Maaari na lang nilang ideklarang 'persona non grata' si Ambassador Jing Quan- iyan na ang pinakasimpleng paraan.")

Ayon sa embahada, si Jing Quan bilang embahador ay may

pananagutan sa lahat ng salita at kilos ng Chinese Embassy.

Mayroon nang 29 taong karanasan ni Jing Quan sa diplomasya, -23 taon dito ay ginugol sa mahihirap na yugto ng ugnayang China-US, kabilang ang trade wars, sanctions, pagsasara ng konsulado, at pagpapalayas ng mga diplomat.

"Throughout all of this, Ambassador Jing never blinked his eyes, steadfastly defending China's interests and dignity because this is the duty and responsibility of a diplomat."

"Shut up!" sabi ni Carlos na pinaalalahanan na masyadong mase-lang usapin ang diplomasya at hindi basta-basta magmumungkahi si Sotto na magdeklara na persona non grata ang isang opisyal ng dayuhang embahada sa Pilipinas.

Nag-ugat ang palitan nang maaanghang na salita nang kutya in, gawing karikatura ng katataw-an ni Philippine Coast Guard spokesperson Commodore Jay Tarriela si Chinese Pres. Xi Jinping.

Sa maraming pagkakataon, binabanatan ni Tarriela ang China sa pang-aagaw ng malaking bahagi ng West Philippine Sea sa teritoryo ng South China Sea.

Ito naman ay mahig-pit na pinabubulaanan ng China.

The wheel of development

Man, the subject of most of the development efforts, is placed at the center of the inner circle because, accordingly, man is the center of development.

In the drawing, eight double lines connect the outer and inner circles of the wheel.

And, I label in between each of the eight double lines as follows: economic, social, cultural, mor-

al, spiritual, political,

physical and technological.

The figure, dubbed as the "wheel of development" depicts the connections of various aspects of man's life and his development, basically through the educational system — whether formal, non-formal or informal in nature.

The various aspects of man's holistic development in the micro-level is discussed as follows:

Economic development. Man must prosper in everything that he pur-

sues in life for him to avoid subsistence production. He must have surplus of his produce so that his proceeds could be used for other purposes, aside from sustaining his families' basic needs.

Social development. Once economically self-sufficient, man could already engage in the other activities of the community, thus, he could contribute for the improvement of his neighborhood.

Cultural development. Further development in life, allows man to divert his efforts in participation in the cultural activities in the community where he belongs.

Moral and spiritual development. These two aspects in the life of man are sometimes being neglected.

of spending his resources now succumb to enter local politics and lead his

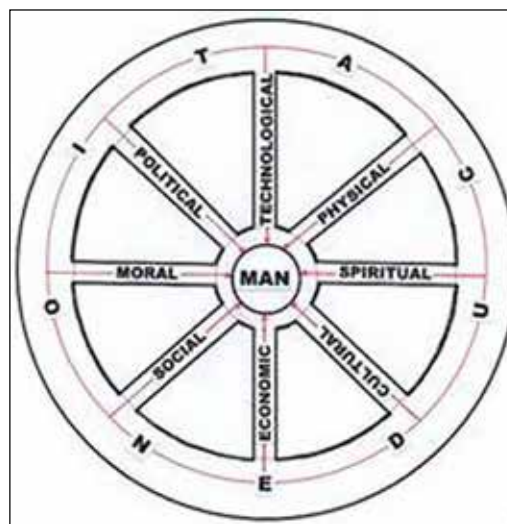
cally, psychologically, and mentally, will contribute to the productivity of man.
